A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County – Illegal Dumping and Litter Control Law – Adoption of**
3 **Local Ordinance**

4 **MC 11–15**

5 FOR the purpose of authorizing the governing body of Montgomery County to adopt a
6 certain ordinance to prohibit littering and to impose certain criminal and civil
7 penalties; and generally relating to the Illegal Dumping and Litter Control Law.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Criminal Law**

21 10–110.

22 (f) (1) A person who violates this section is subject to the penalties provided
23 in this subsection.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 (2) (i) A person who disposes of litter in violation of this section in an
2 amount not exceeding 100 pounds or 27 cubic feet and not for commercial gain is guilty of
3 a misdemeanor and on conviction is subject to imprisonment not exceeding 30 days or a
4 fine not exceeding \$1,500 or both.

5 (ii) A person who disposes of litter in violation of this section in an
6 amount exceeding 100 pounds or 27 cubic feet, but not exceeding 500 pounds or 216 cubic
7 feet, and not for commercial gain is guilty of a misdemeanor and on conviction is subject to
8 imprisonment not exceeding 1 year or a fine not exceeding \$12,500 or both.

9 (iii) A person who disposes of litter in violation of this section in an
10 amount exceeding 500 pounds or 216 cubic feet or in any amount for commercial gain is
11 guilty of a misdemeanor and on conviction is subject to imprisonment not exceeding 5 years
12 or a fine not exceeding \$30,000 or both.

13 (3) In addition to the penalties provided under paragraph (2) of this
14 subsection, a court may order the violator to:

15 (i) remove or render harmless the litter disposed of in violation of
16 this section;

17 (ii) repair or restore any property damaged by, or pay damages for,
18 the disposal of the litter in violation of this section;

19 (iii) perform public service relating to the removal of litter disposed
20 of in violation of this section or to the restoration of an area polluted by litter disposed of in
21 violation of this section; or

22 (iv) reimburse the State, county, municipal corporation, or bi-county
23 unit for its costs incurred in removing the litter disposed of in violation of this section.

24 (j) (1) The legislative body of a municipal corporation may:

25 (i) prohibit littering; and

26 (ii) classify littering as a municipal infraction under Title 6 of the
27 Local Government Article.

28 (2) The governing bodies of Prince George's County [and], Calvert County,
29 **AND MONTGOMERY COUNTY** may each adopt an ordinance to prohibit littering under
30 this section and, for violations of the ordinance, may impose criminal penalties and civil
31 penalties that do not exceed the criminal penalties and civil penalties specified in
32 subsection (f)(1) through (3) of this section.

33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
34 October 1, 2015.
