A BILL ENTITLED

1 AN ACT concerning

2 **Procurement – Veteran–Owned Small Business Enterprise Participation –**
3 **Award of Contracts**

4 FOR the purpose of requiring a unit awarding a contract with a certain expected goal of
5 veteran–owned small business enterprise participation to award the contract in
6 accordance with certain provisions of law to a certain bidder or offeror that meets or
7 makes a good faith effort to meet the expected goals; and generally relating to
8 veteran–owned small business enterprise participation in State procurements.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – State Finance and Procurement**

22 14–602.

23 (a) Beginning July 1, 2012, a unit shall structure procurement procedures,
24 consistent with the purposes of this subtitle, to try to achieve an overall minimum of 0.5%

1 of the unit's total dollar value of procurement contracts to be made directly or indirectly
2 with veteran-owned small business enterprises.

3 (b) Solicitation documents shall establish the expected degree of veteran-owned
4 small business enterprise participation based, in part, on:

5 (1) the potential subcontract opportunities available in the procurement
6 contract; and

7 (2) the availability of veteran-owned small business enterprises to respond
8 competitively to the potential subcontract opportunities.

9 (c) The provisions of this subtitle do not apply to a unit's procurement procedures
10 to the extent that any unit determines that those provisions are in conflict with an
11 applicable federal program.

13 A unit **AWARDING A CONTRACT WITH AN EXPECTED GOAL OF VETERAN-OWNED**
14 **SMALL BUSINESS ENTERPRISE PARTICIPATION AS ESTABLISHED UNDER THIS**
15 **SUBTITLE** shall award the contract **IN ACCORDANCE WITH § 13-103(E) OF THIS**
16 **ARTICLE** to [the] A responsible bidder [that submits the lowest responsive bid, or
17 responsible] **OR** offeror [proposing the most advantageous offer,] that meets or makes a
18 good faith effort to meet [any applicable goal established under this subtitle] **THE**
19 **EXPECTED GOAL.**

20 **SECTION 2. AND BE IT FURTHER ENACTED,** That this Act shall take effect
21 October 1, 2015.
