16 (D) (1) FOR EACH TAXABLE YEAR BEGINNING AFTER DECEMBER 31, 17 2015, EACH MINIMUM AND MAXIMUM STANDARD DEDUCTION LIMITATION AMOUNT 18 SPECIFIED IN SUBSECTION (C) OF THIS SECTION SHALL BE INCREASED BY AN 19 AMOUNT EQUAL TO THE PRODUCT OF MULTIPLYING THE MINIMUM AND MAXIMUM 20 STANDARD DEDUCTION LIMITATION AMOUNT TIMES THE COST-OF-LIVING 21 ADJUSTMENT SPECIFIED IN THIS SUBSECTION.

1 (2) FOR PURPOSES OF THIS SUBSECTION, THE COST-OF-LIVING 2 ADJUSTMENT IS THE COST-OF-LIVING ADJUSTMENT WITHIN THE MEANING OF § 3 1(F)(3) OF THE INTERNAL REVENUE CODE FOR THE CALENDAR YEAR IN WHICH A 4 TAXABLE YEAR BEGINS, AS DETERMINED BY THE COMPTROLLER BY SUBSTITUTING 5 "CALENDAR YEAR 2014" FOR "CALENDAR YEAR 1992" IN § 1(F)(3)(B) OF THE 6 INTERNAL REVENUE CODE.

7 (3) IF ANY INCREASE DETERMINED UNDER PARAGRAPH (1) OF THIS
8 SUBSECTION IS NOT A MULTIPLE OF \$50, THE INCREASE SHALL BE ROUNDED DOWN
9 TO THE NEXT LOWEST MULTIPLE OF \$50.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 11 1, 2015.
