A BILL ENTITLED

1 AN ACT concerning

Workers' Compensation – Heart Disease and Hypertension Presumption – Anne Arundel County Correctional Officers

FOR the purpose of extending the presumption of compensability under the workers' 4 $\mathbf{5}$ compensation law to include, subject to certain conditions, Anne Arundel County 6 correctional officers who suffer from heart disease or hypertension resulting in 7 partial or total disability or death; requiring Anne Arundel County correctional 8 officers to submit certain medical disclosures to a certain official; providing that, 9 subject to a certain limitation, workers' compensation benefits received under this Act are in addition to certain retirement benefits; altering the definition of "public 10 11 safety employee" to include Anne Arundel County correctional officers for the 12purposes of determining certain compensation; providing for the application of 13 certain provisions of this Act; and generally relating to compensability of Anne Arundel County correctional officers under the workers' compensation law. 14

 $\mathbf{2}$ (b) A paid police officer employed by an airport authority, a county, the (1)3 Maryland–National Capital Park and Planning Commission, a municipality, or the State, 4 a deputy sheriff of Montgomery County, or, subject to paragraph (2) of this subsection, a deputy sheriff of Anne Arundel County, ANNE ARUNDEL COUNTY CORRECTIONAL $\mathbf{5}$ 6 **OFFICER**, deputy sheriff of Baltimore City, Montgomery County correctional officer, Prince 7 George's County deputy sheriff. Prince George's County correctional officer, or deputy 8 sheriff of Allegany County is presumed to be suffering from an occupational disease that 9 was suffered in the line of duty and is compensable under this title if:

12 (ii) the heart disease or hypertension results in partial or total 13 disability or death.

14(2)A deputy sheriff of Anne Arundel County, ANNE ARUNDEL (i) **COUNTY CORRECTIONAL OFFICER**, [a] deputy sheriff of Baltimore City, Montgomery 15County correctional officer, Prince George's County deputy sheriff, or Prince George's 16 17County correctional officer is entitled to the presumption under this subsection only to the 18extent that the individual suffers from heart disease or hypertension that is more severe 19 than the individual's heart disease or hypertension condition existing prior to the individual's employment as a deputy sheriff of Anne Arundel County, ANNE ARUNDEL 2021**COUNTY CORRECTIONAL OFFICER**, deputy sheriff of Baltimore City, Montgomery 22County correctional officer, Prince George's County deputy sheriff, or Prince George's 23County correctional officer.

24To be eligible for the presumption under this subsection, a deputy (ii) 25sheriff of Anne Arundel County, ANNE ARUNDEL COUNTY CORRECTIONAL OFFICER, 26[a] deputy sheriff of Baltimore City, Montgomery County correctional officer, Prince 27George's County deputy sheriff, or Prince George's County correctional officer, as a 28condition of employment, shall submit to a medical examination to determine any heart 29disease or hypertension condition existing prior to the individual's employment as a deputy 30 sheriff of Anne Arundel County, ANNE ARUNDEL COUNTY CORRECTIONAL OFFICER, deputy sheriff of Baltimore City, Montgomery County correctional officer, Prince George's 3132County deputy sheriff, or Prince George's County correctional officer.

6 The benefits received under this title shall be adjusted so that the (2)7weekly total of those benefits and retirement benefits does not exceed the weekly salary 8 that was paid to the paid law enforcement employee of the Department of Natural 9 Resources, a park police officer or employee of the Maryland-National Capital Park and Planning Commission, firefighter, firefighting instructor, sworn member of the Office of the 10 11 State Fire Marshal, police officer, deputy sheriff, [or] Prince George's County or Montgomery County correctional officer, OR ANNE ARUNDEL COUNTY CORRECTIONAL 1213**OFFICER**.

1 (2) Is entitled to the presumption under § 9–503(b) of the Labor and 2 Employment Article, as enacted by Section 1 of this Act, only to the extent that the 3 individual suffers from heart disease or hypertension that is more severe than the 4 individual's heart disease or hypertension condition existing as of the date of the medical 5 report provided under item (1) of this section.

6 SECTION 4. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall be 7 construed to apply only prospectively and may not be applied or interpreted to have any 8 effect on or application to any claims arising from events occurring before the effective date 9 of this Act.

10 SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2015.
