the promotion of the success or defeat of a candidate ..."; i.e., to enhance the electability of the person on whose behalf the campaign finance entity is established; and

WHEREAS, State election law does not explicitly specify or limit the categories of expenditures that a campaign finance entity may make from a campaign account to "... promote or assist in the promotion of the success or defeat of a candidate ..."; and

WHEREAS, A letter of advice issued July 22, 2009, by the Attorney General of Maryland, Office of Counsel to the General Assembly, advises that campaign funds may not be used to fund a State legislator's travel, lodging, meals, and registration expenses at a legislative conference; and

WHEREAS, The purposes of many such meetings and conferences are to: (1) educate participants about the legislative process; (2) inform participants regarding other states' legislative solutions to similar problems that may be impacting Maryland; and (3) engage participants about issues and strategies to address matters emanating from the federal government; now, therefore,

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article - Election Law

- 18 1–101.
- 19 (o) (1) "Contribution" means the gift or transfer, or promise of gift or transfer, 20 of money or other thing of value to a campaign finance entity to promote or assist in the 21 promotion of the success or defeat of a candidate, political party, or question.
- 22 (2) "Contribution" includes:
- 23 (i) proceeds from the sale of tickets to a campaign fund-raising 24 event; and
- 25 (ii) a disbursement or deposit of money or a gift, a subscription, an 26 advance, or anything of value that is made by a person in coordination with, or at the 27 request or suggestion of, a candidate or a campaign finance entity of a candidate.
- 28 (aa) "Expenditure" means a gift, transfer, disbursement, or promise of money or a 29 thing of value by or on behalf of a campaign finance entity to:
- 30 (1) promote or assist in the promotion of the success or defeat of a 31 candidate, political party, or question at an election; [or]
- 32 (2) pay for the publication expense of a legislative newsletter under Title 33 13, Subtitle 4 of this article; **OR**

(3) PAY FOR TRAVEL, LODGING, MEALS, AND REGISTRATION EXPENSES OF AN ELECTED OFFICIAL OR A CANDIDATE THAT ARE ASSOCIATED WITH
ATTENDANCE AT MEETINGS OR CONFERENCES FOCUSED ON LEGISLATIVE ISSUES, PROCESS, OR PUBLIC POLICY ANALYSIS PERTINENT TO THE OFFICE THAT THE ELECTED OFFICIAL HOLDS OR THAT THE CANDIDATE SEEKS.
SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2015 .
