1 AN ACT concerning 2 Alcoholic Beverages - Direct Wine Shippers - Reporting Requirements 3 FOR the purpose of requiring a direct wine shipper to report information about wine 4 shipments to the Office of the Comptroller in the manner determined by the Office 5 of the Comptroller, rather than report certain information according to a certain 6 schedule; and generally relating to reports by direct wine shippers in the State. 7 BY repealing and reenacting, with amendments, 8 Article 2B – Alcoholic Beverages 9 Section 7.5–107 10 Annotated Code of Maryland 11 (2011 Replacement Volume and 2014 Supplement) 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: 13 14 Article 2B – Alcoholic Beverages 15 7.5-107.16 A direct wine shipper shall: (a) 17 Ensure that all containers of wine shipped directly to a consumer in the (1) 18 State are conspicuously labeled with: 19 (i) The name of the direct wine shipper; 20(ii) The name and address of the consumer who is the intended 21 recipient; and
