## A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County – Regulation of Parking on York Road**

3 FOR the purpose of prohibiting Baltimore County from placing or maintaining a traffic  
4 control device that regulates parking on York Road in the county unless the county  
5 provides to certain persons notice and an opportunity to address the issue at a public  
6 hearing; providing for the application of this Act; and generally relating to the  
7 regulation of parking on York Road in Baltimore County.

8 BY repealing and reenacting, with amendments,

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Transportation**

16 25–105.

17 (a) On every highway under its jurisdiction, the State Highway Administration  
18 shall place and maintain those traffic control devices that it considers necessary to carry  
19 out the provisions of the Maryland Vehicle Law or to regulate, warn, or guide traffic. Each  
20 of these traffic control devices shall conform to the manual and specifications of the State  
21 Highway Administration.

22 (b) **(1)** A local authority may place or maintain a traffic control device on a  
23 highway under the jurisdiction of the State Highway Administration only with the  
24 permission and under the direction of the State Highway Administration.

1           **(2) (I) BALTIMORE COUNTY MAY NOT PLACE OR MAINTAIN A**  
2 **TRAFFIC CONTROL DEVICE THAT REGULATES PARKING ON YORK ROAD IN THE**  
3 **COUNTY UNLESS THE COUNTY PROVIDES, TO THE GENERAL PUBLIC AND EACH**  
4 **MEMBER OF THE GENERAL ASSEMBLY AND COUNTY COUNCIL WHO REPRESENTS**  
5 **THE REGULATED AREA OR AREA PROPOSED TO BE REGULATED, NOTICE AND AN**  
6 **OPPORTUNITY TO ADDRESS THE ISSUE AT A PUBLIC HEARING.**

7           **(II) THIS PARAGRAPH APPLIES TO ANY TRAFFIC CONTROL**  
8 **DEVICE PLACED OR MAINTAINED BY THE COUNTY ON YORK ROAD ON OR AFTER**  
9 **JUNE 1, 2014.**

10           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
11 1, 2015.
