Election Law - Primary Election Dates in the Presidential Election Year

- 3 FOR the purpose of altering the date of the statewide primary election in the year in which 4 the President of the United States is elected; altering the date of the primary election 5 for municipal offices in Baltimore City in the year in which the President of the 6 United States is elected; making certain conforming changes; clarifying certain provisions of law concerning the filling of certain vacancies in nomination; repealing 7 8 an obsolete provision of law concerning the printing of certain ballots; and generally 9 relating to primary election dates in the presidential election year and the 10 nomination of candidates.

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 18 That the Laws of Maryland read as follows:

 17 CITY ARE elected, by [July 1] THE DATE AND TIME SPECIFIED FOR A CANDIDATE TO
 18 FILE A CERTIFICATE OF CANDIDACY; and
- 19 (iii) for a special election to fill a vacancy for Representative in 20 Congress, by the date and time specified for a candidate to file a certificate of candidacy in 21 the Governor's proclamation.
- 22 (4) A candidate who seeks nomination by petition may not be charged a fee 23 for filing the declaration of intent.



- A vacancy in nomination under this section that occurs because the 1 (b) 2 nominee dies, withdraws the candidacy, or is disqualified for any reason shall be filled by: 3 (i) a vote of the central committees of the political party in each of the counties included in the district of that nominee; or 4 5 (ii) a State central committee for a nonprincipal political party that 6 does not have local central committees. 7 (2)The central committee of each county shall cast a vote that is 8 proportionate to its share of the population in that district as reported in the most recent decennial census of the United States and promptly notify its State central committee of 9 the results of its vote. 10 11 (3)If no person receives a majority of the votes cast under paragraph 12 (2) of this subsection, or if there is a tie vote by the central committees, the vacancy in 13 nomination shall be filled by the State central committee. 14 In the event of a tie vote, the nominee selected by the State central committee shall be one of the candidates involved in the tie. 15 16 By the later of the 40th day before the general election or the fifth day 17 following FOLLOWING the death, declination, or disqualification of the nominee, BY THE **60TH DAY BEFORE THE GENERAL ELECTION:** 18 the State central committee shall file a certificate of designation 19 (i) for the nominee with the State Board: and 20 21the successor nominee designated by the State central committee under subparagraph (i) of this paragraph shall file a certificate of candidacy with the State 22 23Board. 245-1004.25If a nominee for an office that is entirely in one county dies, declines the 26 nomination, becomes disqualified, or gains a tie vote with another candidate in a primary 27election, the vacancy in nomination shall be filled by [the later of:

- 18 (i) in the year in which the Governor is elected, on the last Tuesday 19 in June; and
- 20 (ii) in the year in which the President of the United States is elected, 21 on the [first] **SECOND** FOURTH Tuesday in April.
- 22 (b) In Baltimore City, there shall be a primary election for municipal offices on 23 the [first] SECOND FOURTH Tuesday in April in the year in which the President of the 24 United States is elected.

- (c) (1) The Secretary of State shall certify to the State Board the names of candidates for nomination by a principal political party [during the period beginning 90 days before the primary election and ending 80] NO LATER THAN 90 days before the primary election.
- 30 (2) The Secretary of State shall certify the name of a presidential candidate 31 on the ballot when the Secretary has determined, in the Secretary's sole discretion and 32 consistent with party rules, that the candidate's candidacy is generally advocated or 33 recognized in the news media throughout the United States or in Maryland, unless the 34 candidate executes and files with the Secretary of State an affidavit stating without
