A BILL ENTITLED

1 AN ACT concerning

2 **Deer Bow Hunting Season – Private Property – Additional Sunday in January**

3 FOR the purpose of authorizing a person to hunt deer on private property with a bow and
4 arrow or crossbow during open season on a certain Sunday, subject to certain
5 provisions of law; and generally relating to Sunday hunting.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Natural Resources**

19 10–410.

20 (a) (1) Except as provided in paragraphs (2), (3), (4), (6), (7), (8), and (9) of this
21 subsection, a person may not hunt any game bird or mammal on Sundays.

22 (2) The following persons may hunt the specified game birds and mammals
23 on Sundays:

1 (i) A person using State certified raptors to hunt game birds or
2 mammals during open season;

3 (ii) An unarmed person participating in an organized fox chase to
4 chase foxes;

5 (iii) Provided that the provisions of § 10–906(b)(3) of this title are
6 met, a person:

7 1. Using a regulated shooting ground under § 10–906 of this
8 title to hunt the following pen-reared game birds:

9 A. Pheasants;

10 B. Bobwhite quail;

11 C. Chukar partridge;

12 D. Hungarian partridge;

13 E. Tower released flighted mallard ducks; and

14 F. Turkey on a regulated shooting ground that was permitted
15 to release turkey before September 1, 1992; and

16 2. Having the written permission of the owner of the land or
17 other person designated by the owner of the land, if the land is owned or leased by a person
18 other than the person hunting on Sundays;

19 (iv) Subject to the provisions of [§] §§ 10–411 AND 10–415 of this
20 subtitle[, in]:

21 1. IN Calvert, Caroline, Carroll, Charles, Dorchester,
22 Harford, Queen Anne’s, St. Mary’s, Somerset, Talbot, Wicomico, and Worcester counties, a
23 person hunting deer on private property with a bow and arrow or crossbow during open
24 season on the last three Sundays in October and the second Sunday in November; AND

25 2. A PERSON HUNTING DEER ON PRIVATE PROPERTY
26 WITH A BOW AND ARROW OR CROSSBOW DURING OPEN SEASON ON A SUNDAY IN THE
27 SECOND HALF OF JANUARY, AS DESIGNATED BY THE DEPARTMENT;

28 (v) In Calvert County, Caroline County, Charles County, Dorchester
29 County, and St. Mary’s County, a person hunting turkey on private property on any Sunday
30 during the spring turkey hunting season; and

1 (vi) In Dorchester County, a person hunting turkey on public land
2 that is designated for hunting by the Department on any Sunday during the spring turkey
3 hunting season.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
5 1, 2015.
