### Drunk Driving – Accidents Resulting in Death – Sanctions for Administrative Per Se Offenses

4 FOR the purpose of altering the administrative sanctions for certain alcohol-related 5 administrative per se offenses applicable to a person who was involved in a motor 6 vehicle accident that resulted in the death of another person; expanding the list of 7 issues that may be considered during a certain hearing to include whether a certain 8 person was involved in a motor vehicle accident that resulted in the death of another 9 person; altering the circumstances under which the Motor Vehicle Administration is 10 required to take certain actions and the actions the Administration may take against 11 a person's driver's license for certain administrative per se offenses; authorizing the 12 Administration, under certain circumstances, to issue a certain restrictive license to 13 allow for participation in the Ignition Interlock System Program by a person whose 14 license is suspended or revoked under this Act; making conforming changes; and 15 generally relating to motor vehicle accidents resulting in death and administrative 16 sanctions for alcohol–related administrative per se offenses.
