Family Law – Information and Services for Foster Children and Former Foster
Children

FOR the purpose of requiring a juvenile court, in certain permanency planning and 4 5 guardianship review hearings, to make a finding as to whether a local department 6 of social services has made reasonable efforts to take certain actions for a child who 7 is at least a certain age; requiring a local department to advise a child before 8 emancipation of the right to reenter care and procedures for reentering care under 9 certain provisions of law; requiring a local department to contact a certain former 10 child in need of assistance under certain circumstances and advise the child of the 11 right to reenter care and procedures for reentering care under certain provisions of 12 law; requiring a local department to document certain efforts; requiring the Social 13 Services Administration to adopt certain regulations to require that all children in 14 foster care who are at least 18 years of age have certain documents, information, and 15 records at emancipation; altering the information that the Administration is 16 required to give certain children in out-of-home placement annually; requiring the 17 Department of Human Resources to report to the General Assembly on or before a 18 certain date on certain plans of each local department of social services to provide 19 and promote affordable housing and employment opportunities for former foster 20 youth; requiring the plans to include certain information; and generally relating to 21 information and services for foster youth and former foster youth.

9 10 11	(b) (1) In a hearing conducted in accordance with \S 3–815, \S 3–817, \S 3–819, or \S 3–823 of this subtitle, the court shall make a finding whether the local department made reasonable efforts to prevent placement of the child into the local department's custody.
12 13 14	(2) In a review hearing conducted in accordance with \S 3–823 of this subtitle or \S 5–326 of the Family Law Article, the court shall make a finding whether a local department made reasonable efforts to:
15	(i) Finalize the permanency plan in effect for the child; [and]

- child in accordance with a voluntary placement agreement under § 5–525(b)(1)(i) or (iii) of the Family Law Article.
- 3 (4) The court shall require a local department to provide evidence of its 4 efforts before the court makes a finding required under this subsection.
- 5 (5) The court's finding under this subsection shall assess the efforts made 6 since the last adjudication of reasonable efforts and may not rely on findings from prior 7 hearings.

- 10 (b) (3) (i) The Administration shall establish a program of out-of-home 11 placement for former CINAs:
- who did not exit foster care due to reunification, adoption, guardianship, marriage, or military duty.
- 17 (ii) The Administration shall adopt regulations that include 18 eligibility requirements in accordance with federal law and regulations for providing 19 assistance to individuals at least 18 years old.
- 20 (iii) A local department may not seek legal custody of a former CINA 21 under a voluntary placement agreement.
- (iv) A former CINA described in subparagraph (i) of this paragraph may remain in an out—of—home placement under a voluntary placement agreement for more than 180 days if the former CINA continues to comply with the voluntary placement agreement and a juvenile court makes a finding that the continuation of the placement is in the best interests of the former CINA.

 - (2) The information provided under paragraph (1) of this subsection shall include information regarding tuition assistance, health care benefits, [and] HOUSING, job training and internship opportunities, AND THE RIGHT TO REENTER CARE AND PROCEDURES FOR REENTERING CARE UNDER SUBSECTION (B)(3) OF THIS SECTION.

- SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December 1, 2015, the Department of Human Resources shall report to the General Assembly, in accordance with § 2–1246 of the State Government Article, on the plans of each local department of social services for partnering to provide and promote affordable housing and employment opportunities for former foster youth. The plans shall:
- 18 (1) describe any existing efforts to address the housing and employment 19 needs of former foster youth, including how Family Unification Program vouchers are used 20 to support youth aging out of foster care;
- 21 (2) propose new strategies, including ways to partner with private and 22 public sector employers and workforce development entities, including the Governor's 23 Workforce Investment Board and local workforce investment boards, to provide job 24 opportunities for former foster youth;
- 25 (3) provide and take into account projections of the number of youth 26 expected to transition out of foster care each year for the next 4 years; and
- 27 (4) propose potential partnerships with the Department of Housing and 28 Community Development, local public housing authorities, and community—based 29 organizations to support the placement of foster youth into safe and stable housing.
