A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Law – Death Penalty – Murder of Law Enforcement Officer,**
3 **Correctional Officer, First Responder, or Witness**

4 FOR the purpose of providing that a person who is convicted of first degree murder may be
5 sentenced to death under certain circumstances; providing that the murder of a law
6 enforcement officer, a correctional officer, a certain first responder, or a certain
7 witness, under certain circumstances is an aggravating circumstance that the court
8 or jury must consider in making a determination as to the imposition of the death
9 penalty; establishing certain procedures for custody, warrant of execution,
10 incompetency, method of execution, witnesses, certificate, disposition of body, notice,
11 and trial and sentencing in relation to the imposition of the death penalty; requiring
12 the Department of Public Safety and Correctional Services to complete a presentence
13 investigation report in each case in which the death penalty was requested under a
14 certain provision of law; providing that the juvenile court does not have jurisdiction
15 over a child of a certain age alleged to have done an act which, if committed by an
16 adult, would be a crime punishable by death, as well as certain other charges, unless
17 a certain order has been filed; providing that the juvenile court may waive the
18 exclusive jurisdiction conferred by a certain provision of law with respect to a petition
19 alleging delinquency by a child who has not reached a certain age, but who is charged
20 with committing an act which if committed by an adult, would be punishable by
21 death; authorizing a trial judge to strike an individual from a jury on the basis of the
22 individual's belief for or against capital punishment only if the judge finds that the
23 belief would prevent or substantially impair the individual from returning an
24 impartial verdict according to law; providing that an individual struck from a jury
25 under a certain provision of law may serve on another jury for which the basis for
26 the strike is irrelevant; applying a certain provision of law relating to peremptory
27 challenges to a criminal trial in which a defendant is subject, on any single count, to
28 a death sentence because the State has given a certain notice of intention to seek a
29 death sentence or a sentence of life imprisonment, including a case in which the State
30 has not given a certain notice of intention to seek a death sentence; providing that a
31 certain provision of law authorizing a court that issued an execution on a forfeited

1 recognizance for a certain witness to discharge the witness from execution on a
2 certain motion does not apply in a case if capital punishment may be involved;
3 providing that the Court of Appeals has exclusive appellate jurisdiction over a
4 criminal case in which the death penalty is imposed and any appellate proceeding
5 under a certain provision of law relating to certain incompetent inmates; requiring
6 a court to dismiss a certain charge against a certain defendant found incompetent to
7 stand trial when charged with a capital offense, after the expiration of a certain
8 number of years; prohibiting the release of a defendant on personal recognizance if
9 the defendant is charged with a crime punishable by death; applying the Uniform
10 Postconviction Procedure Act to a person convicted in any court in the State who is
11 confined under sentence of death; adding certain provisions to the Uniform
12 Postconviction Procedure Act for proceedings after death sentences; specifying that
13 the review of a sentence of death is governed by certain provisions of law; prohibiting
14 a review panel from increasing a sentence to the sentence of death; providing that a
15 victim's representative has the same right to address the jury in a death penalty
16 sentencing as a victim's representative has to address a court in a certain other
17 sentencing or disposition hearing; creating certain procedures relating to the
18 determination of whether a victim's representative may present an oral address to
19 the jury in a death penalty sentencing; authorizing the Court of Appeals to adopt
20 rules of procedure to govern the conduct of death penalty sentencing proceedings;
21 establishing certain procedures for the review of a death sentence by the Court of
22 Appeals; providing that certain provisions of law relating to multiple convictions for
23 a crime of violence do not apply if a person is sentenced to death; creating certain
24 exceptions; making conforming, stylistic, and clarifying changes; and generally
25 relating to the death penalty.

37 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
38 That the Laws of Maryland read as follows:

39 **Article – Correctional Services**

1 **SUBTITLE 9. DEATH PENALTY PROCEDURES.**

2 **3-901.**

3 **(A) WHENEVER AN INDIVIDUAL IS SENTENCED TO DEATH, THE JUDGE OF**
4 **THE COURT IN WHICH THE CONVICTION TAKES PLACE SHALL CAUSE THE**
5 **INDIVIDUAL TO BE TAKEN INTO CUSTODY BY THE SHERIFF OF THE COUNTY IN WHICH**
6 **THE INDIVIDUAL WAS INDICTED.**

7 **(B) (1) WHILE THE INMATE IS IN THE CUSTODY OF THE SHERIFF, THE**
8 **SHERIFF SHALL:**

9 **(I) HOLD THE INMATE UNDER GUARD AS THE SHERIFF**
10 **DETERMINES TO BE NECESSARY; AND**

11 **(II) KEEP THE INMATE IN SOLITARY CONFINEMENT IN THE SAME**
12 **MANNER AS IS REQUIRED WHEN THE INMATE IS IN THE CUSTODY OF THE**
13 **DEPARTMENT.**

14 **(2) AS SOON AS POSSIBLE, THE SHERIFF SHALL DELIVER THE INMATE**
15 **TO THE DEPARTMENT TO AWAIT THE EXECUTION OF THE INMATE'S SENTENCE.**

16 **(C) THE EXPENSES OF THE DEPARTMENT RELATING TO THE DETENTION OF**
17 **AN INMATE UNDER SENTENCE OF DEATH, INCLUDING THE EXPENSES OF GUARDING,**
18 **LODGING, FEEDING, CLOTHING, AND CARING FOR THE INMATE, MAY NOT BE**
19 **ASSESSED AGAINST, BILLED TO, OR PAID BY THE COUNTY IN WHICH THE INMATE WAS**
20 **INDICTED.**

21 **3-902.**

22 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
23 **INDICATED.**

24 **(2) (I) “STATE POSTCONVICTION REVIEW PROCESS” MEANS THE**
25 **INITIAL ADJUDICATION OF A POSTCONVICTION PETITION FILED UNDER §**
26 **7-103 OF THE CRIMINAL PROCEDURE ARTICLE, INCLUDING ANY APPELLATE**
27 **REVIEW OF THE POSTCONVICTION PROCEEDING.**

28 **(II) “STATE POSTCONVICTION REVIEW PROCESS” DOES NOT**
29 **INCLUDE:**

1 1. A POSTCONVICTION PROCEEDING THAT HAS BEEN
2 REOPENED UNDER § 7-104 OF THE CRIMINAL PROCEDURE ARTICLE OR ANY
3 APPELLATE REVIEW OF THE PROCEEDING; OR

4 2. A POSTCONVICTION PROCEEDING ON A SECOND
5 PETITION FILED BEFORE OCTOBER 1, 1995, OR ANY APPELLATE REVIEW OF THE
6 PROCEEDING.

7 (3) “WARRANT OF EXECUTION” MEANS A WARRANT FOR THE
8 EXECUTION OF A SENTENCE OF DEATH ON THE INDIVIDUAL AGAINST WHOM THE
9 SENTENCE WAS IMPOSED.

10 (B) A WARRANT OF EXECUTION SHALL:

11 (1) STATE THE CONVICTION AND SENTENCE;

12 (2) DESIGNATE A 5-DAY PERIOD, BEGINNING ON A MONDAY, WITHIN
13 WHICH THE SENTENCE MUST BE EXECUTED; AND

14 (3) COMMAND THE SECRETARY TO CARRY OUT THE DEATH PENALTY
15 ON A DAY WITHIN THE DESIGNATED PERIOD.

16 (C) AT THE TIME AN INDIVIDUAL IS SENTENCED TO DEATH, THE JUDGE
17 PRESIDING IN THE COURT SHALL ISSUE A WARRANT OF EXECUTION DIRECTED TO
18 THE SECRETARY.

19 (D) (1) A WARRANT OF EXECUTION IS STAYED DURING THE DIRECT
20 REVIEW PROCESS AND THE STATE POSTCONVICTION REVIEW PROCESS.

21 (2) IF THE ORIGINAL WARRANT OF EXECUTION HAS NOT EXPIRED AT
22 THE END OF THE STATE POSTCONVICTION REVIEW PROCESS, THE JUDGE WHO
23 IMPOSED THE SENTENCE OF DEATH OR THE JUDGE THEN PRESIDING IN THE COURT
24 IN WHICH THE SENTENCE WAS IMPOSED SHALL LIFT THE STAY IMPOSED UNDER
25 PARAGRAPH (1) OF THIS SUBSECTION.

26 (3) IF THE ORIGINAL WARRANT OF EXECUTION HAS EXPIRED AT THE
27 END OF THE STATE POSTCONVICTION REVIEW PROCESS, THE JUDGE WHO IMPOSED
28 THE SENTENCE OF DEATH OR THE JUDGE THEN PRESIDING IN THE COURT IN WHICH
29 THE SENTENCE WAS IMPOSED SHALL ISSUE ANOTHER WARRANT OF EXECUTION.

30 (E) (1) IF THE GOVERNOR IS SATISFIED THAT A MEDICAL EXAMINATION
31 SHOWS THAT AN INMATE IS PREGNANT, THE GOVERNOR SHALL REVOKE A WARRANT
32 OF EXECUTION FOR THE INMATE.

1 **(2) AS SOON AS THE GOVERNOR IS SATISFIED THAT THE INMATE IS**
2 **NO LONGER PREGNANT, THE GOVERNOR PROMPTLY SHALL ISSUE ANOTHER**
3 **WARRANT OF EXECUTION.**

4 **(F) (1) THE GOVERNOR MAY GRANT A STAY OF A WARRANT OF**
5 **EXECUTION FOR ANY CAUSE.**

6 **(2) IF THE GOVERNOR GRANTS A STAY UNDER THIS SUBSECTION:**

7 **(I) THE GOVERNOR SHALL ISSUE AN ORDER REVOKING THE**
8 **WARRANT OF EXECUTION; AND**

9 **(II) THE SENTENCE OF DEATH MAY NOT BE EXECUTED UNTIL**
10 **THE GOVERNOR ISSUES ANOTHER WARRANT OF EXECUTION.**

11 **(3) THE GOVERNOR PROMPTLY SHALL NOTIFY THE SECRETARY OF**
12 **AN ORDER THAT REVOKES A WARRANT OF EXECUTION.**

13 **(G) (1) THE SECRETARY SHALL SET A TIME, WITHIN THE PERIOD**
14 **DESIGNATED IN THE WARRANT OF EXECUTION, WHEN THE SENTENCE OF DEATH**
15 **SHALL BE EXECUTED.**

16 **(2) NO PREVIOUS ANNOUNCEMENT OF THE DAY OR TIME OF THE**
17 **EXECUTION MAY BE MADE EXCEPT TO THOSE WHO ARE INVITED OR ALLOWED TO BE**
18 **PRESENT AS PROVIDED IN THIS SUBTITLE.**

20 **(A) IN THIS SECTION, "OFFICIAL" MEANS:**

21 **(1) THE SECRETARY; OR**

22 **(2) THE SHERIFF OF THE COUNTY IN WHICH AN INMATE WAS**
23 **INDICTED.**

24 **(B) (1) IF THE GOVERNOR GRANTS A REPRIEVE TO AN INMATE UNDER**
25 **SENTENCE OF DEATH OR A COURT IMPOSES A STAY ON THE EXECUTION OF A**
26 **SENTENCE OF DEATH, THE GOVERNOR OR COURT SHALL SERVE NOTICE OF THE**
27 **REPRIEVE OR STAY ON:**

28 **(I) THE INMATE; AND**

1 **(II) THE OFFICIAL WHO HAS CUSTODY OF THE INMATE.**

2 **(2) THE OFFICIAL WHO HAS CUSTODY OF THE INMATE SHALL OBEY**
3 **THE REPRIEVE OR STAY.**

4 **(C) AN INMATE WHO IS GRANTED A REPRIEVE OR STAY SHALL REMAIN IN**
5 **THE CUSTODY OF THE OFFICIAL WHO RECEIVES NOTICE UNDER SUBSECTION**
6 **(B)(1)(II) OF THIS SECTION.**

7 **(D) (1) IN ANY SUBSEQUENT JUDICIAL PROCEEDING, THE COURT SHALL**
8 **SERVE ANY COURT ORDER REGARDING AN INMATE ON:**

9 **(I) THE INMATE; AND**

10 **(II) THE OFFICIAL WHO HAS CUSTODY OF THE INMATE.**

11 **(2) IF A COURT RESENTENCES AN INMATE TO DEATH, THE**
12 **PROVISIONS OF THIS SUBTITLE SHALL APPLY TO THE NEW SENTENCE IN THE SAME**
13 **MANNER AS THE ORIGINAL SENTENCE.**

14 **(3) (I) IF A NEW TRIAL IS GRANTED TO AN INMATE WHO IS IN THE**
15 **CUSTODY OF THE SECRETARY, THE INMATE SHALL BE TRANSPORTED BACK TO THE**
16 **PLACE OF TRIAL UNDER GUARD AS THE SECRETARY DIRECTS.**

17 **(II) THE EXPENSES RELATING TO THE TRANSPORTATION OF AN**
18 **INMATE BACK TO THE PLACE OF TRIAL UNDER SUBPARAGRAPH (I) OF THIS**
19 **PARAGRAPH SHALL BE PAID BY THE DEPARTMENT.**

21 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
22 **INDICATED.**

23 **(2) "INCOMPETENT" MEANS THE STATE OF MIND OF AN INMATE WHO,**
24 **AS A RESULT OF A MENTAL DISORDER OR OF MENTAL RETARDATION, LACKS**
25 **AWARENESS:**

26 **(I) OF THE FACT OF THE INMATE'S IMPENDING EXECUTION;**
27 **AND**

28 **(II) THAT THE INMATE IS TO BE EXECUTED FOR THE CRIME OF**
29 **MURDER.**

1 **(3) "INMATE" MEANS AN INDIVIDUAL WHO HAS BEEN CONVICTED OF**
2 **MURDER AND SENTENCED TO DEATH.**

3 **(B) AN INMATE IS NOT INCOMPETENT UNDER THIS SECTION MERELY**
4 **BECAUSE THE INMATE'S COMPETENCE DEPENDS ON CONTINUING TREATMENT,**
5 **INCLUDING THE USE OF MEDICATION.**

6 **(C) THE STATE MAY NOT EXECUTE A SENTENCE OF DEATH AGAINST AN**
7 **INMATE WHO HAS BECOME INCOMPETENT.**

8 **(D) (1) A PETITION THAT ALLEGES THAT AN INMATE IS INCOMPETENT**
9 **AND THAT SEEKS TO REVOKE A WARRANT OF EXECUTION AGAINST THE INMATE MAY**
10 **BE FILED BY:**

11 **(I) THE INMATE;**

12 **(II) IF THE INMATE IS REPRESENTED BY COUNSEL, COUNSEL**
13 **FOR THE INMATE; OR**

14 **(III) IF THE INMATE IS NOT REPRESENTED BY COUNSEL, ANY**
15 **OTHER PERSON ON THE INMATE'S BEHALF.**

16 **(2) THE PETITION SHALL BE FILED IN THE CIRCUIT COURT OF THE**
17 **COUNTY IN WHICH THE INMATE IS CONFINED.**

18 **(3) ON THE FILING OF THE PETITION, THE COURT MAY STAY ANY**
19 **WARRANT OF EXECUTION THAT WAS PREVIOUSLY ISSUED AND HAS NOT YET**
20 **EXPIRED.**

21 **(4) THE PETITION MUST BE ACCOMPANIED BY AN AFFIDAVIT OF AT**
22 **LEAST ONE PSYCHIATRIST THAT:**

23 **(I) IS BASED, AT LEAST IN PART, ON PERSONAL EXAMINATION;**

24 **(II) STATES THAT IN THE PSYCHIATRIST'S MEDICAL OPINION**
25 **THE INMATE IS INCOMPETENT; AND**

26 **(III) STATES THE PERTINENT FACTS ON WHICH THE OPINION IS**
27 **BASED.**

28 **(5) A COPY OF THE PETITION SHALL BE SERVED ON THE ATTORNEY**
29 **GENERAL AND THE OFFICE OF THE STATE'S ATTORNEY THAT PROSECUTED THE**

1 INMATE, IN ACCORDANCE WITH THE SERVICE REQUIREMENTS OF THE MARYLAND
2 RULES.

3 (6) UNLESS THE INMATE IS ALREADY REPRESENTED BY COUNSEL,
4 THE COURT PROMPTLY SHALL APPOINT THE PUBLIC DEFENDER OR, IF THE PUBLIC
5 DEFENDER FOR GOOD CAUSE DECLINES REPRESENTATION, OTHER COUNSEL TO
6 REPRESENT THE INMATE IN THE PROCEEDING.

7 (7) UNLESS THE STATE'S ATTORNEY STIPULATES TO THE INMATE'S
8 INCOMPETENCE, THE STATE'S ATTORNEY SHALL CAUSE THE INMATE TO BE
9 EXAMINED AND EVALUATED BY ONE OR MORE PSYCHIATRISTS SELECTED BY THE
10 STATE'S ATTORNEY.

11 (8) IF THE INMATE'S REQUEST IS REASONABLE AND TIMELY, AN
12 INMATE IS ENTITLED TO BE INDEPENDENTLY EXAMINED BY A PSYCHIATRIST THAT
13 THE INMATE SELECTS.

14 (9) UNLESS, WITH THE COURT'S APPROVAL, THE PARTIES WAIVE A
15 HEARING, THE ADMINISTRATIVE JUDGE OF THE COURT SHALL DESIGNATE A TIME
16 FOR AN EVIDENTIARY HEARING TO DETERMINE THE INMATE'S COMPETENCE.

17 (E) (1) A HEARING UNDER THIS SECTION SHALL BE HELD WITHOUT A
18 JURY:

19 (I) IN COURT;

20 (II) AT THE PLACE WHERE THE INMATE IS CONFINED; OR

21 (III) AT ANOTHER CONVENIENT PLACE.

22 (2) AT THE HEARING, THE INMATE:

23 (I) SUBJECT TO REASONABLE RESTRICTIONS RELATED TO THE
24 INMATE'S CONDITION, MAY BE PRESENT;

25 (II) THROUGH COUNSEL, MAY OFFER EVIDENCE,
26 CROSS-EXAMINE WITNESSES AGAINST THE INMATE, AND MAKE ARGUMENT; AND

27 (III) HAS THE BURDEN OF ESTABLISHING INCOMPETENCE BY A
28 PREPONDERANCE OF THE EVIDENCE.

29 (F) THE COURT SHALL ENTER AN ORDER THAT:

1 **(1) DECLARES THE INMATE TO BE COMPETENT OR INCOMPETENT;**
2 **AND**

3 **(2) STATES THE FINDINGS ON WHICH THE DECLARATION IS BASED.**

4 **(G) IF THE COURT FINDS THE INMATE TO BE COMPETENT, THE COURT**
5 **IMMEDIATELY:**

6 **(1) SHALL LIFT ANY STAY OF A WARRANT OF EXECUTION THAT WAS**
7 **PREVIOUSLY ISSUED AND HAS NOT YET EXPIRED; OR**

8 **(2) IF ALL PREVIOUSLY ISSUED WARRANTS OF EXECUTION HAVE**
9 **EXPIRED, SHALL NOTIFY THE COURT THAT IMPOSED THE SENTENCE OF DEATH AND**
10 **REQUEST THAT THE COURT ISSUE A NEW WARRANT OF EXECUTION.**

11 **(H) (1) IF THE COURT FINDS THE INMATE TO BE INCOMPETENT, THE**
12 **COURT SHALL:**

13 **(I) STAY ANY WARRANT OF EXECUTION THAT WAS PREVIOUSLY**
14 **ISSUED AND HAS NOT YET EXPIRED; AND**

15 **(II) REMAND THE CASE TO THE COURT IN WHICH THE SENTENCE**
16 **OF DEATH WAS IMPOSED.**

17 **(2) THE COURT IN WHICH THE SENTENCE OF DEATH WAS IMPOSED**
18 **SHALL STRIKE THE SENTENCE OF DEATH AND ENTER IN ITS PLACE A SENTENCE OF**
19 **LIFE IMPRISONMENT WITHOUT THE POSSIBILITY OF PAROLE.**

20 **(3) THE SENTENCE OF LIFE IMPRISONMENT WITHOUT THE**
21 **POSSIBILITY OF PAROLE IMPOSED UNDER PARAGRAPH (2) OF THIS SUBSECTION IS**
22 **MANDATORY AND MAY NOT BE SUSPENDED WHOLLY OR PARTLY.**

23 **(I) (1) THERE IS NO RIGHT OF APPEAL FROM AN ORDER ISSUED BY A**
24 **CIRCUIT COURT UNDER THIS SECTION.**

25 **(2) NOTWITHSTANDING PARAGRAPH (1) OF THIS SUBSECTION,**
26 **EITHER PARTY MAY SEEK REVIEW IN THE COURT OF APPEALS BY FILING AN**
27 **APPLICATION FOR LEAVE TO APPEAL IN ACCORDANCE WITH THE MARYLAND**
28 **RULES.**

29 **(3) IF AN APPLICATION FOR LEAVE TO APPEAL IS FILED, THE COURT**
30 **OF APPEALS MAY STAY ANY WARRANT OF EXECUTION THAT WAS PREVIOUSLY**
31 **ISSUED AND HAS NOT YET EXPIRED.**

1 **(J) (1) NOT EARLIER THAN 6 MONTHS AFTER A FINDING OF**
2 **COMPETENCE, THE INMATE MAY PETITION THE COURT FOR A REDETERMINATION**
3 **OF COMPETENCE.**

4 **(2) THE PETITION MUST BE ACCOMPANIED BY AN AFFIDAVIT OF AT**
5 **LEAST ONE PSYCHIATRIST THAT:**
