| 16              | SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,                           |



- 1 (b) (1) Except as provided in subsection (e) of this section, a business entity
  2 may claim a tax credit in the amounts determined under subsections (c) and (d) of this
  3 section for the wages and qualified child care or transportation expenses with respect to a
  4 qualified employee with a disability that are paid in the taxable year for which the business
  5 entity claims the credit.
- 6 (2) The same tax credit cannot be applied more than once against different 7 taxes by the same taxpayer.
- 8 (c) For each taxable year, for the wages paid to each qualified employee with a 9 disability, a credit is allowed in an amount equal to [:
- 10 (1)] 30% of up to the first [\$6,000] **\$9,000** of the wages paid to the qualified 11 employee with a disability during **EACH OF** the [1st year] **FIRST 2 YEARS** of employment[; 12 and
- 13 (2) 20% of up to the first \$6,000 of the wages paid to the qualified employee with a disability during the 2nd year of employment].
- 15 (d) For each taxable year, for child care provided or paid for by a business entity 16 for the children of a qualified employee with a disability, or transportation expenses that 17 are incurred by a business entity to enable a qualified employee with a disability to travel 18 to and from work, a credit is allowed in an amount equal to [:
- 19 (1) Up] UP to [\$600] **\$900** of the qualified child care or transportation 20 expenses incurred for each qualified employee with a disability during **EACH OF** the first 21 [year] **2 YEARS** of employment[; and
- 22 (2) Up to \$500 of the qualified child care or transportation expenses 23 incurred for each qualified employee with a disability during the second year of 24 employment].
- 25 (e) (1) A business entity may not claim the credit under this section for an 26 employee:
- 27 (i) Who is hired to replace a laid-off employee or to replace an 28 employee who is on strike; or
- 29 (ii) For whom the business entity simultaneously receives federal or 30 State employment training benefits.
- 31 (2) A business entity may not claim the credit under this section until it 32 has notified the Division that a qualified employee with a disability has been hired.

- 1 A business entity may claim a credit in the amount provided in 2 paragraph [(5)] (4) of this subsection for an employee whose employment lasts less than 1 3 year if the employee: 4 (i) Voluntarily terminates employment with the employer; 5 (ii) Is unable to continue employment due to a further disability or 6 death: or 7 (iii) Is terminated for cause. 8 A business entity may not claim the credit under this section if the 9 business entity is claiming a tax credit for the same employee under § 10–704.3 of the Tax 10 - General Article. 11 (5)If a business entity is entitled to a tax credit for an employee who 12 is employed for less than 1 year because the employee voluntarily terminates employment with the employer to take another job, the business entity may claim a tax credit of 30% of 13 up to the first [\$6,000] **\$9,000** of the wages paid to the employee during the course of 14 15 employment. 16 If a business entity is entitled to a tax credit for an employee who (ii) 17 is employed for less than 1 year for a reason other than that described in subparagraph (i) 18 of this paragraph, the amount of the credit shall be reduced by the proportion of a year that 19 the employee did not work. 20 If the credit allowed under this section in any taxable year exceeds the total 21tax otherwise payable by the business entity for that taxable year, a business entity may 22apply the excess as a credit for succeeding taxable years until the earlier of: 23The full amount of the excess is used; or (1) 24The expiration of the 5th taxable year after the taxable year in which the wages or qualified child care or transportation expenses for which the credit is claimed 2526 are paid. 27 If a credit is claimed under this section, the claimant must make the addition 28required in § 10–205 or § 10–306 of the Tax – General Article. 29 Subject to the provisions of this subsection, the Department of Labor, (h) (1)30 Licensing, and Regulation and the State Department of Education shall jointly adopt regulations necessary to carry out the provisions of this section. 31
- 32 (2) The Comptroller shall adopt regulations to provide for the computation and carryover of the credit under § 10–704.7 of the Tax General Article.

- 1 (3)The State Department of Assessments and Taxation shall adopt 2 regulations to provide for the computation and carryover of the credit under §§ 8–216 and 3 8–413 of the Tax – General Article. - SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2015, and shall be applicable to all taxable years beginning after December 31, 2014.
