2 Corporations – Maryland General Corporation Law – Miscellaneous Provisions

3 FOR the purpose of clarifying the rights of a subscriber for shares of stock of a corporation; 4 providing that an individual, whether or not then a director, may assent to an action $\mathbf{5}$ by a consent that will be effective at a future time under certain circumstances; 6 providing that a person, whether or not then a stockholder, may assent to an action 7 by a consent that will be effective at a future time under certain circumstances; providing that certain consents shall be deemed to have been given at the effective 8 9 time under certain circumstances; providing that certain consents are revocable 10 before the effective time unless otherwise provided in the consents; altering the 11 circumstances under which certain mergers may be approved by the board of 12 directors of a corporation, without a meeting of the stockholders; defining certain 13terms; making certain conforming and stylistic changes; and generally relating to the Maryland General Corporation Law. 14
