## 1 AN ACT concerning

## St. Mary's County - Animal Regulations

- 3 FOR the purpose of repealing provisions authorizing the County Commissioners of St. Mary's County to pass rules, regulations, or resolutions relating to dog licenses, the 4 prohibition of dogs running at large off the property of the owner, the seizure and  $\mathbf{5}$ 6 disposal of dogs found running at large, and the confinement of female dogs in heat; 7 repealing provisions authorizing the county commissioners to delegate, by written 8 contract, the enforcement of certain rules, regulations, or resolutions; authorizing 9 the county commissioners to enact a local law to provide a comprehensive system for 10 the regulation, humane treatment, and keeping of domestic animals and wild 11 animals kept in captivity; authorizing a certain local law to include a schedule of 12 fines for designated violations; providing that a violation of a certain local law is a 13civil infraction; and generally relating to the regulation of certain animals in St. 14 Mary's County.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

 $\mathbf{2}$ (a) In St. Mary's County, on or before June 30 of each year, a person owning (1)3 or keeping a dog shall apply to the county tax collector for a license for the dog if the dog is at least 6 months old. 4

At the time of application, the applicant shall pay the fee for a dog or  $\mathbf{5}$ (2)6 kennel license set by the County Commissioners of St. Mary's County.

- 7 (3)(i) The county commissioners shall appoint agents to collect dog and 8 kennel license fees that are not paid by August 1 of each year.
- 9 (ii) A penalty of \$1.00 per license shall be assessed against dog owners whose dog or kennel license fees are not paid by August 1 each year. 10

11 (4)Except as provided in § 13–108 of this subtitle, the licenses and fees 12required under this section shall be the only licenses and fees required for owning or 13keeping a dog.

14The county commissioners shall prepare and supply the form for a (5)15license issued under this subsection.

16 A dog license shall contain the date of issuance, a serial number, and a (6)17description of the dog licensed.

18 (7)A license expires on June 30 of the year after issuance.

19 (b) (1)In St. Mary's County, the county tax collector shall issue a tag with each 20dog license to a person owning or keeping a dog when the person pays the license fee for 21the dog.

22The County Commissioners of St. Mary's County shall prepare and (2)23supply tags to the county tax collector each year.

(3) Before the county commissioners pass a rule, regulation, or resolution in accordance with this subsection, the proposed rule, regulation, or resolution shall be advertised in a newspaper of general circulation in the county once each week for 4 successive weeks, to provide any person an opportunity to be heard.

1 (g) (1) In St. Mary's County, the owner or custodian of a female dog that is in 2 heat shall:

- 3 (i) adequately and securely confine the dog;
- 4 (ii) prevent the dog from contacting roaming dogs; and

5 (iii) protect the dog from other dogs that are attracted to the 6 premises.

7 (2) A person who violates this subsection is guilty of a misdemeanor and 8 on conviction is subject to a fine of not less than \$10 and not exceeding \$50.]

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 October 1, 2015.
