1 AN ACT concerning

2 Cigarette Restitution Fund – Use of Funds – Compliance With Watershed 3 Implementation Plans

4 FOR the purpose of allowing the Cigarette Restitution Fund to be used to provide financial $\mathbf{5}$ assistance to farmers to be used for certain purposes; establishing the Watershed 6 Implementation Plan Fund as a special, nonlapsing fund; specifying the purpose of 7 the Fund; requiring the Department of Agriculture to administer the Fund; requiring 8 the State Treasurer to hold the Fund and the Comptroller to account for the Fund; specifying the contents of the Fund; specifying the purpose for which the Fund may 9 be used; providing for the investment of money in and expenditures from the Fund; 1011 requiring the Department to adopt certain regulations; requiring the Department to 12make a certain report to the General Assembly on or before a certain date; defining 13 a certain term; providing for the application of this Act; and generally relating to the use of certain money from the Cigarette Restitution Fund and certain financial 14 assistance to farmers. 15

- 16 (J) MONEY EXPENDED FROM THE FUND FOR FINANCIAL ASSISTANCE TO 17 FARMERS IS SUPPLEMENTAL TO AND IS NOT INTENDED TO TAKE THE PLACE OF 18 FUNDING THAT OTHERWISE WOULD BE APPROPRIATED FOR FINANCIAL ASSISTANCE 19 TO FARMERS.
