Community Colleges - Tuition Waiver for Full-Time Students - Partial State Reimbursement

4 FOR the purpose of exempting certain individuals who enroll as full-time certificate or 5 associate's degree students at a community college in the State from payment of 6 tuition under certain circumstances; requiring certain individuals to apply for 7 certain financial aid; providing the conditions under which an individual is no longer 8 eligible for a tuition waiver; requiring certain individuals to be counted in a certain 9 computation of State and local aid to community colleges; specifying how financial aid shall be applied for individuals who receive a tuition waiver; requiring the State 10 11 to reimburse community colleges for a certain percentage of foregone tuition revenue; 12 requiring that funds used by the State to reimburse community colleges shall be paid 13 from the Education Trust Fund from funds allocated from a certain source; requiring 14 certain individuals who do not satisfy certain requirements to repay the amount of 15 the tuition waived; authorizing the Maryland Higher Education Commission to 16 adopt certain regulations; defining a certain term; and generally relating to a tuition 17 waiver for certain individuals who enroll as full-time certificate or associate's degree 18 students at community colleges in the State.

5 6	(A) (1) IN THIS SECTION, "TUITION" MEANS THE BASIC INSTRUCTIONAL CHARGE FOR COURSES OFFERED AT A COMMUNITY COLLEGE.
7	(2) "TUITION" INCLUDES ANY FEES FOR:
8	(I) REGISTRATION;
9	(II) APPLICATION;
10	(III) ADMINISTRATION; OR
11	(IV) LABORATORY WORK.
12	(B) (1) THIS SUBSECTION APPLIES TO AN INDIVIDUAL WHO:

- 1 (C) AN INDIVIDUAL WHO RECEIVES A TUITION WAIVER UNDER SUBSECTION 2 (B) OF THIS SECTION SHALL CONTINUE TO RECEIVE THE TUITION WAIVER UNTIL THE 3 EARLIER OF ONE OF THE FOLLOWING CONDITIONS:
- 4 (1) THE INDIVIDUAL DOES NOT MAINTAIN A GRADE POINT AVERAGE 5 OF AT LEAST 2.0 ON A 4.0 SCALE AND IS NOT MAKING SATISFACTORY PROGRESS 6 TOWARD A VOCATIONAL CERTIFICATE OR AN ASSOCIATE'S DEGREE;
- 7 (2) 2–1/2 YEARS HAVE PASSED AFTER THE INDIVIDUAL FIRST 8 ENROLLED AS A FULL-TIME STUDENT IN A VOCATIONAL CERTIFICATE PROGRAM OR 9 AN ASSOCIATE'S DEGREE PROGRAM AT A COMMUNITY COLLEGE IN THE STATE; OR
- 10 (3) THE INDIVIDUAL IS AWARDED A VOCATIONAL CERTIFICATE OR AN 11 ASSOCIATE'S DEGREE.
- 12 **(D) (1)** ANY STUDENT FINANCIAL AID, OTHER THAN A STUDENT LOAN, 13 RECEIVED BY AN INDIVIDUAL WHO RECEIVES A TUITION WAIVER UNDER 14 SUBSECTION (B) OF THIS SECTION SHALL BE APPLIED FIRST TO PAY THE 15 INDIVIDUAL'S TUITION.
- 16 (2) THE TUITION WAIVER SHALL APPLY TO THE DIFFERENCE, IF ANY, 17 BETWEEN THE CHARGE FOR TUITION AND THE FINANCIAL AID AWARD, NOT 18 INCLUDING A STUDENT LOAN, THAT THE INDIVIDUAL RECEIVES.
- 19 (3) ON REQUEST, THE COMMUNITY COLLEGE SHALL ASSIST ANY 20 INDIVIDUAL REQUIRED TO SUBMIT AN APPLICATION FOR STATE OR FEDERAL 21 STUDENT FINANCIAL AID UNDER THIS SECTION.
- (E) (1) A COMMUNITY COLLEGE IS ENTITLED TO REIMBURSEMENT FROM
 THE STATE FOR 50% OF THE FORGONE TUITION REVENUE RESULTING FROM
 TUITION WAIVERS AWARDED IN ACCORDANCE WITH THIS SECTION.
- 25 (2) Funds used by the State to reimburse a community College for forgone tuition revenue shall be paid from the Education Trust Fund from the funds allocated under § 9–1A–27 of the State Government Article.
- (F) THE RECIPIENT OF A TUITION WAIVER UNDER SUBSECTION (B) OF THIS
 SECTION SHALL REPAY THE AMOUNT OF TUITION WAIVED IF THE RECIPIENT DOES
 NOT SATISFY THE REQUIREMENTS TO BE AWARDED A VOCATIONAL CERTIFICATE OR
 AN ASSOCIATE'S DEGREE WITHIN 3 YEARS AFTER FIRST RECEIVING A TUITION
 WAIVER.

- 1 (G) THE COMMISSION MAY ADOPT REGULATIONS NECESSARY TO 2 IMPLEMENT THE PROVISIONS OF THIS SECTION, INCLUDING DEVELOPING A 3 PROCESS FOR:

- 10 (a) There is an Education Trust Fund which is a special, nonlapsing fund that is 11 not subject to § 7–302 of the State Finance and Procurement Article.
- 12 (b) (1) There shall be credited to the Education Trust Fund all proceeds allocated to the Fund under § 9–1A–27 of this subtitle.
- 14 (2) Money in the Education Trust Fund shall be invested and reinvested by the Treasurer, and interest and earnings shall accrue to the Fund.
- 16 (c) Money in the Education Trust Fund shall be used to:
- 17 (1) provide funding for public elementary and secondary education, 18 through continuation of the funding and formulas established under the programs 19 commonly known as the Bridge to Excellence in Public Schools Act, first enacted by Chapter 20 288 of the Acts of the General Assembly of 2002, including the funding for regional 21 differences in the cost of education under § 5–202(f) of the Education Article;
- 22 (2) provide funds to construct public school buildings and provide public school capital improvements in accordance with §§ 5–301 through 5–303 of the Education Article;
- 25 (3) provide funds for capital projects at community colleges and public 26 senior higher education institutions; [and]
- 27 (4) provide funds to expand public early childhood education programs in 28 the State; AND
- 29 (5) PROVIDE FUNDS TO REIMBURSE COMMUNITY COLLEGES FOR 30 FORGONE TUITION REVENUE IN ACCORDANCE WITH § 16–106.1 OF THE EDUCATION 31 ARTICLE.

- 1 (d) Expenditures from the Education Trust Fund shall be made each fiscal year 2 in accordance with the State budget.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 4 $\,$ 1, 2015.
