10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to 11 apply retroactively and shall be applied to and interpreted to affect any commissioner 12 appointed to the Maryland–National Capital Park and Planning Commission from 13 Montgomery County on or after June 15, 2014.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2015.
