# A BILL ENTITLED

#### 1 AN ACT concerning

# Department of Health and Mental Hygiene – Birth Registrations – Notice of Placement of Security Freezes

4 FOR the purpose of requiring the administrative head of a certain institution or a designee  $\mathbf{5}$ of the administrative head or the Secretary of Health and Mental Hygiene to provide 6 a certain notice to the mother, father, or legal guardian of a child relating to security 7 freezes under certain circumstances; requiring the Secretary of Health and Mental 8 Hygiene to provide a certain notice relating to security freezes on a certain form 9 provided by the Secretary; requiring the Consumer Protection Division of the Office 10 of the Attorney General to prepare a notice that explains how to request a consumer 11 reporting agency to place a security freeze on a file relating to an individual under a 12certain age and the benefits of having a freeze on a certain credit file; and generally relating to security freeze information provided to the mother, father, or legal 13guardian of a child at the time of registration of the birth of the child. 14

- (2) In the absence of an attending individual, the father or mother.

14 (c) When a birth occurs on a common carrier within the United States and the 15 child is first removed from the carrier in this State, the birth shall be registered in this 16 State, and the place where the child is first removed shall be considered the place of birth.

17 (d) When a birth occurs on a common carrier while in international waters, air 18 space, or in a foreign country and the child is first removed from the carrier in this State, 19 the birth shall be registered in this State but the certificate shall show the actual place of 20 birth insofar as can be determined.

21 (e) The certificate shall be filed within 5 calendar days after the child is removed 22 from the carrier.

23 (f) (1) Each parent shall provide his or her own Social Security number on the 24 form provided by the Secretary under this section.

(2) (i) If the father is not available to provide his Social Security
number on the form provided under paragraph (1) of this subsection, the father shall
provide his Social Security number on a form provided by the Secretary for this purpose.

State that the form is for the purpose of providing the
