Income Tax Checkoff – Maryland Veterans Trust Fund

- 3 FOR the purpose of establishing a certain income tax checkoff system for voluntary contributions to the Maryland Veterans Trust Fund; requiring the Comptroller to 4 $\mathbf{5}$ include a checkoff on the individual income tax return; providing that the income tax 6 checkoff system include a certain statement; requiring the Comptroller to include 7 certain information in each individual income tax return package; requiring the 8 Comptroller to collect and account for contributions made through the checkoff 9 system and to credit the proceeds to the Fund after deducting the amount necessary to administer the checkoff system; providing that the Fund may consist of certain 10 contributions from the income tax checkoff system and certain other money; 11 12providing for the application of this Act; and generally relating to an income tax 13 checkoff system for contributions to the Maryland Veterans Trust Fund.

(I) THE INDIVIDUAL, OR EACH SPOUSE IN THE CASE OF A JOINT RETURN, MAY CONTRIBUTE TO THE MARYLAND VETERANS TRUST FUND THE AMOUNT DESIGNATED BY THE INDIVIDUAL; AND			
(II) 1. THE INDIVIDUAL SHALL DEDUCT THE AMOUNT OF THE CONTRIBUTION FROM ANY REFUND TO WHICH THE INDIVIDUAL IS ENTITLED; OR			
2. IF THE INDIVIDUAL IS NOT ENTITLED TO A REFUND, THE INDIVIDUAL SHALL ADD THE AMOUNT OF THE CONTRIBUTION TO THE INCOME TAX TO BE PAID WITH THE RETURN.			
(3) THE COMPTROLLER SHALL INCLUDE, WITH THE INDIVIDUAL INCOME TAX RETURN PACKAGE, A DESCRIPTION OF THE PURPOSES FOR WHICH THE MARYLAND VETERANS TRUST FUND WAS ESTABLISHED AND THE PURPOSES FOR WHICH THE FUND MAY BE USED.			
(B) THE COMPTROLLER SHALL:			
(1) COLLECT THE CHECKOFF CONTRIBUTIONS AND ACCOUNT TO THE STATE TREASURER FOR THE MONEY COLLECTED;
