1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loans of 2013 and 2014 – Baltimore City –**
3 **Skatepark of Baltimore at Roosevelt Park**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loans of 2013 and
5 2014 to change the grantees of certain grants; extending the deadline for a grantee
6 to present evidence of a certain matching fund; making this Act an emergency
7 measure; and generally relating to amending the Maryland Consolidated Capital
8 Bond Loans of 2013 and 2014.

12 BY repealing and reenacting, with amendments,

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

2 (W) Skatepark of Baltimore at Roosevelt Park. Provide a grant equal
3 to the lesser of (i) \$75,000 or (ii) the amount of the matching fund

33 Skatepark of Baltimore at Roosevelt Park. Notwithstanding
34 Section 1(5) of this Act, the matching fund may consist of real
35 property or in kind contributions (Baltimore City)..... 50,000

36 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
37 measure, is necessary for the immediate preservation of the public health or safety, has
38 been passed by a yea and nay vote supported by three-fifths of all the members elected to

1 each of the two Houses of the General Assembly, and shall take effect from the date it is
2 enacted.
