- 4 (B) THE REQUIREMENTS UNDER SUBSECTION (A) OF THIS SECTION MUST 5 BE MET BEFORE THE BOARD OF TRUSTEES OF HARFORD COMMUNITY COLLEGE 6 TAKES A FINAL VOTE ON A HARFORD COMMUNITY COLLEGE BUDGET THAT 7 INCLUDES AN INCREASE IN TUITION OVER THE PREVIOUS FISCAL YEAR.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 October 1, 2015.
