22(1) SEARCH DATA FOR FISCAL YEAR 2016 AND EACH YEAR THEREAFTER; AND 23

- 24(2) **SEARCH BY THE FOLLOWING DATA FIELDS:**
- 25**(I)** A PAYEE RECEIVING A PAYMENT; AND
- 26**(II)** THE ZIP CODE OF A PAYEE RECEIVING A PAYMENT.

27THE BOARD SHALL POST IN A TIMELY MANNER ON THE SEARCHABLE **(E)** 28WEB SITE THE PAYMENT DATE REQUIRED UNDER THIS SECTION.

3 (G) THIS SECTION SHALL BE KNOWN AND MAY BE CITED AS THE "ANNE 4 ARUNDEL COUNTY PUBLIC SCHOOLS FUNDING ACCOUNTABILITY AND 5 TRANSPARENCY ACT".

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 7 1, 2015.
