# Election Law – Early Voting Centers – Parking

14SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: 15

6 (f) Beginning 30 days prior to each early voting period the State Board and each 7 local board shall undertake steps to inform the public about early voting and the location 8 of early voting centers in each county, including:

- 10 (2) mailings to all registered voters in each county; and
- 11 (3) other measures as appropriate.

12 (g) Except as expressly provided in this section, any provision of this article that 13 applies to voting on election day also applies to early voting.

14 (h) The State Board shall adopt regulations and guidelines in accordance with the 15 requirements of this section for the conduct of early voting.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2015.
