## Land Use – Plans – Development and Adoption

FOR the purpose of authorizing the legislative body of a local jurisdiction to adopt, modify, 4 remand, or disapprove a certain plan or part of a plan, a plan for one or more geographic sections or divisions of the local jurisdiction, or an amendment ex extension of or addition to the plan; authorizing and requiring the legislative body to hold a public hearing before taking certain actions; requiring a certain planning commission to hold a public hearing before submitting a new recommended plan 9 under certain circumstances; providing that a certain recommendation of a planning commission shall be considered approved if the legislative body of a certain local jurisdiction fails to take action on the recommendation approve, modify, remand, or 12 disapprove the recommended plan within a certain time period; authorizing the legislative body of a local jurisdiction, by resolution, to extend a certain deadline for 13 14 a certain period of time if the legislative body makes a certain determination; making a certain technical correction; and generally relating to the development and adoption of certain land use plans.
