A BILL ENTITLED

1 AN ACT concerning

2 **Wicomico County – Alcoholic Beverages – Micro–Breweries – Annual Production**
3 **Limit**

4 FOR the purpose of raising in Wicomico County the limit on the number of barrels of malt
5 beverages that a micro–brewery may collectively brew, bottle, or contract for in a
6 calendar year; and generally relating to micro–breweries in Wicomico County.

7 BY repealing and reenacting, with amendments,
8 Article 2B – Alcoholic Beverages
9 Section 2–208(c)(1)
10 Annotated Code of Maryland
11 (2011 Replacement Volume and 2014 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article 2B – Alcoholic Beverages**

15 2–208.

16 (c) (1) A holder of a Class 7 micro–brewery license:

17 (i) May brew and bottle malt beverages at the license location;

18 (ii) May obtain a Class 2 rectifying license for a premises located
19 within 1 mile of the existing Class 7 micro–brewery location to bottle malt beverages
20 brewed at the micro–brewery location only;

21 (iii) May contract with the holder of a Class 2 rectifying license held
22 under § 2–203 of this subtitle, a Class 5 brewery license, a Class 7 micro–brewery license,

1 or a Class 8 farm brewery license, or the holder of a nonresident dealer's permit to brew
2 and bottle malt beverages on their behalf;

3 (iv) May store the finished product under an individual storage
4 permit or at a licensed public storage facility for subsequent sale and delivery to a licensed
5 wholesaler, an authorized person outside this State, and for shipment back to the
6 micro-brewery location for sale on the retail premises;

7 (v) May not collectively brew, bottle, or contract for more than:

8 **1. EXCEPT AS PROVIDED IN ITEM 2 OF THIS ITEM, 22,500**
9 **barrels of malt beverages each calendar year; [and] OR**

10 **2. IN WICOMICO COUNTY, 45,000 BARRELS OF MALT**
11 **BEVERAGES EACH CALENDAR YEAR; AND**

12 (vi) May enter into a temporary delivery agreement with a
13 distributor only for delivery of beer to a beer festival or wine and beer festival and the
14 return of any unused beer if:

15 1. The beer festival or wine and beer festival is in a sales
16 territory for which the holder does not have a franchise with a distributor under the Beer
17 Franchise Fair Dealing Act; and

18 2. The temporary delivery agreement is in writing.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
20 1, 2015.
