(c) (1) A holder of a Class 7 micro-brewery license:

17 (i) May brew and bottle malt beverages at the license location;

18 (ii) May obtain a Class 2 rectifying license for a premises located 19 within 1 mile of the existing Class 7 micro-brewery location to bottle malt beverages

20 brewed at the micro-brewery location only;

21 (iii) May contract with the holder of a Class 2 rectifying license held 22 under § 2–203 of this subtitle, a Class 5 brewery license, a Class 7 micro–brewery license,

- or a Class 8 farm brewery license, or the holder of a nonresident dealer's permit to brew and bottle malt beverages on their behalf;
- 3 (iv) May store the finished product under an individual storage 4 permit or at a licensed public storage facility for subsequent sale and delivery to a licensed 5 wholesaler, an authorized person outside this State, and for shipment back to the 6 micro-brewery location for sale on the retail premises;
- 7 (v) May not collectively brew, bottle, or contract for more than:
- 8 **EXCEPT AS PROVIDED IN ITEM 2 OF THIS ITEM,** 22,500 9 barrels of malt beverages each calendar year; [and] **OR**
- 2. IN WICOMICO COUNTY, 45,000 BARRELS OF MALT BEVERAGES EACH CALENDAR YEAR; AND
- 12 (vi) May enter into a temporary delivery agreement with a 13 distributor only for delivery of beer to a beer festival or wine and beer festival and the 14 return of any unused beer if:
- 15 1. The beer festival or wine and beer festival is in a sales territory for which the holder does not have a franchise with a distributor under the Beer Franchise Fair Dealing Act; and
- 18 2. The temporary delivery agreement is in writing.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2015.
