WHEREAS, In December 2014, the United States Congress passed and the President signed into law the Achieving a Better Life Experience (ABLE) Act; and

WHEREAS, The ABLE Act amended the Internal Revenue Code by creating ~~tax exempt~~ a tax exemption for savings accounts to assist individuals with disabilities and their families in building savings to pay for qualified disability expenses; and

WHEREAS, ABLE accounts are intended to supplement, not supplant, essential benefits provided through private insurance, Medicaid, Supplemental Security Income, employment earnings, and other sources of financial support; and

WHEREAS, ABLE accounts can help fund qualified expenses for individuals with disabilities, including medical and dental care, education, housing, transportation, obtaining and maintaining employment, assistive technology, and community-based services and supports; and

1 WHEREAS, The ABLE Act is designed to assist individuals with disabilities and
2 their families to save private funds, through the creation of ABLE accounts, for the purpose
3 of maintaining the health, independence, and quality of life of individuals with disabilities;

5 WHEREAS, The ABLE Act provides the State the opportunity to establish and
6 operate an ABLE savings program to benefit qualified Marylanders with disabilities; ~~and~~

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

12 (a) “Maryland ABLE Program” means a program in Maryland allowing disabled
13 individuals or their families to establish savings accounts to pay qualified expenses for
14 disabled individuals authorized under the federal Achieving a Better Life Experience
15 (ABLE) Act.

21 (1) may not receive compensation as a member of the Task Force; but

22 (2) is entitled to reimbursement for expenses under the Standard State

2 the College Savings Plans of Maryland or another State agency;

3 (3) determine the staffing and funding needs of the program;

4 (4) identify potential sources of start-up funding prior to the program
5 becoming self-supporting;

6 (5) determine the membership of the Board that will oversee the program,
7 the duties of the Board, and the Board's governance structure;

8 (6) determine the State tax benefits or treatment of contributions to and
9 withdrawals from ABLE accounts;

10 (7) hold public hearings for public input to inform the deliberations of the

12 (8) recommend legislation to be introduced in the 2016 Session of the
13 General Assembly that implements the recommendations of the Task Force.
