BY repealing and reenacting, with amendments, Article – Education Section 11-202.2 Annotated Code of Maryland (2014 Replacement Volume and 2014 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Education 11-202.2.(a) (1) In this subtitle the following words have the meanings indicated. (2)"Fully online distance education program in the State" means a program, originating outside the State, offered by an out-of-state institution in which [a]:
