## Baltimore City School Police Force - Carrying of Firearms - Scope

- 3 FOR the purpose of authorizing a Baltimore City school police officer to carry a firearm on
- 4 certain premises of certain public schools and certain other property used for a
- 5 certain purpose; making certain stylistic changes; and generally relating to the
- 6 carrying of firearms by the Baltimore City school police force.

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 18 That the Laws of Maryland read as follows:

#### 19 Article – Education

- 21 (a) In this section, "Baltimore City school police officer" means any person who,
- 22 when acting in an official capacity, is authorized by law to make arrests and who is a
- 23 member of the Baltimore City School Police Force.
  - (b) There is a Baltimore City School Police Force.

## EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.



- 1 (c) The members of the Baltimore City School Police Force shall be employees of 2 and be appointed by the Baltimore City Board of School Commissioners.
- 3 (d) (1) Except as provided in paragraph (3) of this subsection, a Baltimore City 4 school police officer has all the powers of a law enforcement officer in the State.
- 5 (2) (i) A Baltimore City school police officer may act in an official capacity only on the premises of schools and any other property used for [educational purposes] AN EDUCATIONAL PURPOSE owned, leased, or operated by, or under the control of the Baltimore City Board of School Commissioners.
- 9 (ii) A Baltimore City school police officer may not act in an official 10 capacity on any other property unless:
- 11 Engaged in fresh pursuit of a suspected offender;
- 12 2. Requested or authorized to do so by the Police 13 Commissioner of Baltimore City;
- 3. The exercise of power is necessary to facilitate the orderly flow of traffic to and from property owned, leased, operated by, or under the control of the Baltimore City School System; or
- 17 4. Ordered to do so by the Mayor of Baltimore City.
- (3)18 (i) Notwithstanding any other provision of law, a Baltimore City 19 school police officer [whose permanent or temporary assignment is at a school or on school 20 property] may carry a firearm on the premises of [the]A BALTIMORE CITY PUBLIC school 21 Ito which the officer is assigned before or after regular school hours on school days and on 22 days other than school days AND ANY OTHER PROPERTY USED FOR AN EDUCATIONAL 23 PURPOSE OWNED, LEASED, OR OPERATED BY, OR UNDER THE CONTROL OF THE 24BALTIMORE CITY BOARD OF SCHOOL COMMISSIONERS.
- 25 (ii) The Baltimore City Board of School Commissioners shall 26 establish policies to implement the provisions of subparagraph (i) of this paragraph.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2015.
