1 AN ACT concerning

2 **Procurement – Veteran–Owned Small Business Enterprise Participation –**  
3 **Award of Contracts**

4 FOR the purpose of requiring a unit awarding a ~~contract with a certain expected goal of~~  
5 ~~veteran–owned small business enterprise participation to award the contract in~~  
6 ~~accordance with certain provisions of law to a certain bidder or offeror that meets or~~  
7 ~~makes a good faith effort to meet the expected goals~~ contract with a certain goal of  
8 veteran–owned small business participation to comply with certain requirements  
9 depending on the type of procurement being conducted; and generally relating to  
10 veteran–owned small business enterprise participation in State procurements.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
22 That the Laws of Maryland read as follows:

1 **Article – State Finance and Procurement**

2 14–602.

3 (a) Beginning July 1, 2012, a unit shall structure procurement procedures,  
4 consistent with the purposes of this subtitle, to try to achieve an overall minimum of 0.5%  
5 of the unit’s total dollar value of procurement contracts to be made directly or indirectly  
6 with veteran–owned small business enterprises.

7 (b) Solicitation documents shall establish the expected degree of veteran–owned  
8 small business enterprise participation based, in part, on:

9 (1) the potential subcontract opportunities available in the procurement  
10 contract; and

11 (2) the availability of veteran–owned small business enterprises to respond  
12 competitively to the potential subcontract opportunities.

13 (c) The provisions of this subtitle do not apply to a unit’s procurement procedures  
14 to the extent that any unit determines that those provisions are in conflict with an  
15 applicable federal program.

25 (A) [A] FOR PROCUREMENTS CONDUCTED BY COMPETITIVE SEALED  
26 BIDDING, A unit shall award the contract to the responsible bidder that submits the  
27 [lowest] responsive bid[, or responsible offeror proposing the most advantageous offer,]  
28 that:

29 (1) HAS THE LOWEST BID PRICE;

30 (2) HAS THE LOWEST EVALUATED BID PRICE; OR

31 (3) FOR PROCUREMENTS SUBJECT TO § 11–202(3) OF THIS ARTICLE,  
32 IS THE BID MOST FAVORABLE TO THE STATE; AND

1           (4) meets or makes a good faith effort to meet any applicable goal  
2 established under this subtitle.

3           (B) FOR PROCUREMENTS CONDUCTED BY COMPETITIVE SEALED  
4 PROPOSALS, A UNIT SHALL AWARD THE CONTRACT TO THE RESPONSIBLE OFFEROR:

5           (1) PROPOSING THE MOST ADVANTAGEOUS OFFER; AND

6           (2) THAT MEETS OR MAKES A GOOD FAITH EFFORT TO MEET ANY  
7 APPLICABLE GOAL ESTABLISHED UNDER THIS SUBTITLE.

8           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
9 October 1, 2015.
