CHAPTER _____

1 AN ACT concerning

2 **City of Annapolis – Alcoholic Beverages – Election Days**

3 FOR the purpose of adding the City of Annapolis to the list of subdivisions in which a
4 holder of an alcoholic beverages license may exercise all of the privileges conferred
5 by that license on the day of any election in that subdivision; and generally relating
6 to alcoholic beverages in the City of Annapolis.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article 2B – Alcoholic Beverages**

15 11–401.

16 (b) In the enumerated subdivisions below the holder of any license issued under
17 the provisions of this article is permitted to exercise all of the privileges conferred by that
18 license on the day of any election in that subdivision:

3 day of any election during those hours the polls are open;
