Correctional Officers' Retirement System – Membership <u>and Eligibility for</u> <u>Retirement</u>

FOR the purpose of altering the positions eligible for membership in the Correctional Officers' Retirement System to include certain individuals who elect to transfer from the Employees' Retirement System; clarifying that certain individuals who do not elect to transfer are not members of the Correctional Officers' Retirement System; altering certain eligibility requirements for a normal service retirement allowance for members of the Correctional Officers' Retirement System; altering eligibility requirements for a deferred vested retirement allowance for members of the Correctional Officers' Retirement System; authorizing certain individuals to cease membership in the Employees' Retirement System and enroll in the Correctional Officers' Retirement System; authorizing certain individuals to transfer service credit from the Employees' Retirement System to the Correctional Officers' Retirement System; requiring an individual who elects to transfer membership and service credit to the Correctional Officers' Retirement System to make that election on a form provided by the Board of Trustees for the State Retirement and Pension System; requiring service credit transferred to the Correctional Officers' Retirement System under this Act to be transferred in accordance with certain provisions of law; requiring the Executive Director of the State Retirement Agency to grant a certain waiver if it is necessary to implement a certain transfer of service credit; providing that certain provisions of law do not apply to certain individuals who transfer service credit to the Correctional Officers' Retirement System in accordance with certain provisions of law; providing for the termination of certain provisions of this Act; and

18 19 20 21	(b) (1) On or after July 1, 2015, but on or before December 31, 2015, an individual described in subsection (a) of this section may cease membership in the Employees' Retirement System and be enrolled as a member of the Correctional Officers' Retirement System.
22 23 24	(2) An individual who enrolls as a member of the Correctional Officers' Retirement System under paragraph (1) of this subsection may transfer service credit from the Employees' Retirement System to the Correctional Officers' Retirement System.
25 26 27 28	(3) (i) An individual who chooses to enroll in the Correctional Officers' Retirement System under paragraph (1) of this subsection shall do so by filing an application provided by the Board of Trustees for the State Retirement and Pension System.
29 30 31 32	(ii) An individual who chooses to transfer service credit to the Correctional Officers' Retirement System under paragraph (2) of this subsection shall do so by filing an application provided by the Board of Trustees for the State Retirement and Pension System.

1 2 3	(4) (i) Service credit transferred under paragraph (2) of this subsection shall be transferred in the same manner as a transfer of service credit made in accordance with Title 37 of the State Personnel and Pensions Article.
4 5 6	(ii) The Executive Director of the State Retirement Agency shall grant a waiver under § 37–203.2 of the State Personnel and Pensions Article if a waiver is necessary to transfer service credit under paragraph (2) of this subsection.

Section 2 of this Act shall remain effective for a period of 6 months and, at the end of December 31, 2015, with no further action required by the General Assembly, Section 2 of this Act shall be abrogated and of no further force and effect.
