18 19	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

22	(b) If a petition is filed with a commissioner and the commissioner finds that there

are reasonable grounds to believe that the respondent has abused a person eligible for

- relief, the commissioner may issue an interim protective order to protect a person eligible for relief.
