A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County – Education – Youth Wellness Leadership Pilot Program**

3 FOR the purpose of establishing the Youth Wellness Leadership Pilot Program in the State
4 Department of Education; requiring the Department, after consultation with the
5 Department of Health and Mental Hygiene, to implement the Program for a certain
6 number of students in public high schools in Prince George's County; authorizing the
7 State Department of Education to collaborate with certain local community
8 organizations; specifying the purpose of the Program; defining a certain term;
9 requiring the State Department of Education to report annually to certain
10 committees of the General Assembly; providing for the termination of this Act; and
11 generally relating to the Youth Wellness Leadership Pilot Program in Prince
12 George's County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Education**

21 **7–415.1.**

22 **(A) IN THIS SECTION, “PROGRAM” MEANS THE YOUTH WELLNESS**
23 **LEADERSHIP PILOT PROGRAM IN THE DEPARTMENT.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(B) THERE IS A YOUTH WELLNESS LEADERSHIP PILOT PROGRAM IN THE**
2 **DEPARTMENT.**

3 **(C) THE DEPARTMENT, AFTER CONSULTATION WITH THE DEPARTMENT OF**
4 **HEALTH AND MENTAL HYGIENE, SHALL ESTABLISH THE PROGRAM FOR 125**
5 **STUDENTS IN PUBLIC HIGH SCHOOLS IN PRINCE GEORGE'S COUNTY.**

6 **(D) THE DEPARTMENT MAY COLLABORATE WITH LOCAL COMMUNITY**
7 **ORGANIZATIONS INVOLVED IN YOUTH-LED HEALTH AND WELLNESS ADVOCACY**
8 **PROGRAMS.**

9 **(E) THE PURPOSE OF THE PROGRAM IS TO:**

10 **(1) PROMOTE YOUTH-LED HEALTH AND WELLNESS ADVOCACY**
11 **SKILLS; AND**

12 **(2) TEACH STUDENTS WHO PARTICIPATE IN THE PROGRAM SKILLS IN**
13 **THE FOLLOWING AREAS:**

14 **(I) HEALTH AND WELLNESS;**

15 **(II) ACADEMIC PERFORMANCE;**

16 **(III) PEER EDUCATION;**

17 **(IV) LEADERSHIP;**

18 **(V) CAREER DEVELOPMENT; AND**

19 **(VI) ECONOMIC WELL-BEING.**

20 **(F) THE DEPARTMENT SHALL REPORT ANNUALLY TO THE SENATE**
21 **EDUCATION, HEALTH, AND ENVIRONMENTAL AFFAIRS COMMITTEE AND THE**
22 **HOUSE COMMITTEE ON WAYS AND MEANS, IN ACCORDANCE WITH § 2-1246 OF THE**
23 **STATE GOVERNMENT ARTICLE, ON THE EFFECTIVENESS OF THE PROGRAM.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 October 1, 2015. It shall remain effective for a period of 3 years and, at the end of September
26 30, 2018, with no further action required by the General Assembly, this Act shall be
27 abrogated and of no further force and effect.
