## Calvert County - Budget Hearings and Procedures

3 FOR the purpose of altering the procedures for preparing and adopting a budget for Calvert 4 County; requiring each county department, agency, or board receiving county funds 5 to submit a certain itemized budget request on or before a date set by the County 6 Commissioners of Calvert County; requiring the County Commissioners to conduct 7 a public hearing on a certain staff-recommended budget and a subsequent public 8 hearing on the County Commissioners' budget; requiring that one of the newspapers 9 in which a notice of hearings is published be a newspaper of general circulation in 10 the county; providing that the final county budget be adopted after holding the record 11 open for a certain number of days after the hearing on the County Commissioners' 12 budget; requiring that a copy of a proposed county budget be available in a certain 13 manner for a certain minimum time period before each public hearing; making 14 stylistic changes; and generally relating to the procedures for preparing and 15 adopting a budget for Calvert County.

- 3 (a) (1) [At a public hearing held on the] ON OR BEFORE A date set by the
  4 COUNTY Commissioners, each county department, agency, or board receiving county funds
  5 shall submit to the County Commissioners and to the Director of [Administration and]
  6 Finance AND BUDGET, OR THE DIRECTOR'S DESIGNEE, an itemized budget request for
  7 all funds requested for the next fiscal year FOR COMPILATION INTO THE
  8 STAFF-RECOMMENDED BUDGET.
- 9 **(2) (I)** The **COUNTY** Commissioners shall **CONDUCT A PUBLIC**10 **HEARING ON THE STAFF-RECOMMENDED BUDGET AND** publish notice of the time and
  11 place of this hearing in at least two county newspapers for at least two weeks before the
  12 hearing is held.
- 13 (II) AT LEAST ONE OF THE NEWSPAPERS SHALL BE A 14 NEWSPAPER OF GENERAL CIRCULATION IN THE COUNTY.
- 15 (3) At [this] THE hearing ON THE STAFF-RECOMMENDED BUDGET, county citizens may present their views on budget requests and funding levels.
- 17 (b) (1) [Before] AFTER THE HEARING ON THE STAFF-RECOMMENDED
  18 BUDGET AND BEFORE taking final action [on a proposed] TO ADOPT A budget, the County
  19 Commissioners shall [hold a] CONDUCT A SECOND public hearing to permit county
  20 residents to comment on [it] THE COUNTY COMMISSIONERS' BUDGET.
- 21 **(2) (I)** The **COUNTY** Commissioners shall publish notice of the time and place of the hearing **ON THE COUNTY COMMISSIONERS' BUDGET** in at least two county newspapers for at least two weeks before the hearing is held.
- 24 (II) AT LEAST ONE OF THE NEWSPAPERS SHALL BE A 25 NEWSPAPER OF GENERAL CIRCULATION IN THE COUNTY.
- 26 (3) [The] AFTER HOLDING THE RECORD OPEN FOR AT LEAST 10 DAYS
  27 AFTER THE HEARING ON THE COUNTY COMMISSIONERS' BUDGET, THE final COUNTY
  28 budget shall be adopted by a resolution approved by the COUNTY Commissioners.
- 29 (c) (1) [By the time of the first notice of] AT LEAST 1 WEEK BEFORE EACH
  30 public hearing ON A PROPOSED COUNTY BUDGET UNDER THIS SECTION, the proposed
  31 county budget shall be filed with the clerk of the County Commissioners and be available
  32 for public inspection ON THE COUNTY'S WEB SITE.
