1 AN ACT concerning

2 Vehicle Laws - Race-Based Traffic Stops - Policy and Reporting Requirements

3 FOR the purpose of requiring that certain law enforcement officers record certain 4 information pertaining to traffic stops; requiring certain law enforcement agencies 5 to report certain information to the Maryland Statistical Analysis Center; requiring 6 the Police Training Commission to develop a certain format and guidelines and a 7 standardized format for the reporting of certain data; requiring the Police Training 8 Commission to develop a certain model policy; requiring the Maryland Statistical 9 Analysis Center to analyze certain data based on a methodology developed in 10 conjunction with the Police Training Commission; requiring the Maryland Statistical 11 Analysis Center to make certain reports to the General Assembly, the Governor, and 12 law enforcement agencies; requiring law enforcement agency policies regarding 13 race-based traffic stops to provide for certain reviews of certain data and reports for 14 certain purposes; requiring the Maryland Statistical Analysis Center to report to the 15 Police Training Commission those law enforcement agencies that fail to comply with 16 certain reporting requirements; requiring certain actions following a report on the 17 failure of a law enforcement agency to comply; providing certain exceptions applicable to law enforcement agencies that are subject to certain agreements; 18 19 defining certain terms; and generally relating to law enforcement procedures and 20 traffic stops.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

"MARYLAND STATISTICAL ANALYSIS CENTER" MEANS THE 9 **(4)** RESEARCH, DEVELOPMENT, AND EVALUATION COMPONENT OF THE GOVERNOR'S 10 11 OFFICE OF CRIME CONTROL AND PREVENTION. "POLICE TRAINING COMMISSION" MEANS THE UNIT WITHIN THE 12 DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES ESTABLISHED 13 UNDER § 3-202 OF THE PUBLIC SAFETY ARTICLE. 14 15 [(4)] (6) "Traffic stop" means any instance when a law enforcement (i) 16 officer stops the driver of a motor vehicle and detains the driver for any period of time for a violation of the Maryland Vehicle Law. 17 18 "Traffic stop" does not include: (ii) 19 1. A checkpoint or roadblock stop; 20 2. A stop of multiple vehicles due to a traffic accident or 21emergency situation requiring the stopping of vehicles for public safety purposes; 22 3. A stop based on the use of radar, laser, or vascar 23technology; or 244. A stop based on the use of license plate reader technology.

- 1 (2) A LAW ENFORCEMENT AGENCY THAT IS EXEMPT UNDER SUBSECTION (C)(2) OF THIS SECTION SHALL SUBMIT TO THE MARYLAND STATISTICAL ANALYSIS CENTER COPIES OF REPORTS IT SUBMITS TO THE UNITED STATES DEPARTMENT OF JUSTICE IN LIEU OF THE REPORT REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION.
- 6 (F) (1) THE MARYLAND STATISTICAL ANALYSIS CENTER SHALL 7 ANALYZE THE ANNUAL REPORTS OF LAW ENFORCEMENT AGENCIES SUBMITTED 8 UNDER SUBSECTION (E) OF THIS SECTION BASED ON A METHODOLOGY DEVELOPED 9 IN CONSULTATION WITH THE POLICE TRAINING COMMISSION.
- 10 (2) THE MARYLAND STATISTICAL ANALYSIS CENTER SHALL SUBMIT
 11 A REPORT OF THE FINDINGS TO THE GOVERNOR, THE GENERAL ASSEMBLY IN
 12 ACCORDANCE WITH § 2–1246 OF THE STATE GOVERNMENT ARTICLE, AND EACH
 13 LAW ENFORCEMENT AGENCY BEFORE SEPTEMBER 1 OF EACH YEAR.
- [(b)] (G) (1) A law enforcement agency shall adopt a policy against race—based traffic stops that is to be used as a management tool to promote nondiscriminatory law enforcement and in the training and counseling of its officers.
- 17 (2) (i) The policy shall prohibit the practice of using an individual's race 18 or ethnicity as the sole justification to initiate a traffic stop.
- 19 (ii) The policy shall make clear that it may not be construed to alter 20 the authority of a law enforcement officer to make an arrest, conduct a search or seizure, 21 or otherwise fulfill the officer's law enforcement obligations.
- 22 (3) THE POLICY SHALL PROVIDE FOR THE LAW ENFORCEMENT
 23 AGENCY TO PERIODICALLY REVIEW DATA COLLECTED BY ITS OFFICERS UNDER
 24 SUBSECTION (D) OF THIS SECTION AND TO REVIEW THE ANNUAL REPORT OF THE
 25 MARYLAND STATISTICAL ANALYSIS CENTER FOR PURPOSES OF PARAGRAPH (1) OF
 26 THIS SUBSECTION.
- 27 (H) (1) If a law enforcement agency fails to comply with the Reporting provisions of this section, the Maryland Statistical Analysis 29 Center shall report the noncompliance to the Police Training 30 Commission.

 32 ENFORCEMENT AGENCY AND REQUEST THAT THE AGENCY COMPLY WITH THE
