A BILL ENTITLED

1 AN ACT concerning

2 **Funeral Establishments and Crematories – Unclaimed Cremains**
3 **of Veterans – Disposition**

4 FOR the purpose of requiring licensed funeral establishments or holders of permits for the
5 business of operating a crematory in the possession of unclaimed cremated human
6 remains for a certain period of time to provide certain identifying information to the
7 Maryland Department of Veterans Affairs or certain veterans service organizations
8 for a certain determination; requiring the Maryland Department of Veterans Affairs
9 or veterans service organization to make a certain notification of certain information
10 within a certain period of time; authorizing a licensed funeral establishment or
11 permit holder to transfer certain cremains to the Maryland Department of Veterans
12 Affairs or a veterans service organization for certain disposition under certain
13 circumstances; establishing that a licensed funeral establishment, holder of a permit
14 for a crematory, or certain veterans service organization that acts in good faith when
15 taking certain actions is not civilly liable; defining certain terms; and generally
16 relating to the disposition of unclaimed cremains of veterans.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Business Regulation**

19 5–101.

20 (a) In this title the following words have the meanings indicated.

21 (e) “Cremation” means the process of reducing human remains to bone fragments
22 through intense heat and evaporation, including any mechanical or thermal process.

23 (f) “Crematory” means a building, portion of a building, or structure that houses
24 the necessary appliances and facilities for cremation.

25 (g) “Director” means the Director of the Office of Cemetery Oversight.

26 (i) (1) “Engage in the operation of a crematory” means controlling or
27 managing a crematory.

28 (2) “Engage in the operation of a crematory” does not include:

29 (i) the practice of funeral direction or the practice of mortuary
30 science; or

31 (ii) 1. assistance in making decisions and filling out forms that
32 are not directly related to cremation;

1 2. obtaining vital statistics, signatures, and other
2 information necessary to complete a death certificate;

3 3. transportation of a body to the place of disposition; or

4 4. any other services regarding the disposition of a body that
5 are not directly related to cremation.

6 (k) (1) “Human remains” means:

7 (i) the body of a deceased person; or

8 (ii) a part of a body or limb that has been removed from a living
9 person.

10 (2) “Human remains” includes the body or part of a body or limb in any
11 state of decomposition.

12 (n) “Permit” means a permit issued by the Director to allow a partnership, limited
13 liability company, or corporation to operate a business through which a registrant may:

14 (1) engage in the operation of a cemetery or crematory; or

15 (2) provide burial goods.

19 (2) **“ELIGIBLE DEPENDENT” MEANS A VETERAN’S SPOUSE, A**
20 **VETERAN’S UNMARRIED CHILD UNDER THE AGE OF 21 YEARS, OR A VETERAN’S**
21 **UNMARRIED ADULT CHILD WHO BEFORE THE AGE OF 21 BECAME PERMANENTLY**
22 **INCAPABLE OF SELF-SUPPORT BECAUSE OF PHYSICAL OR MENTAL DISABILITY.**

23 (3) (i) **“IDENTIFYING INFORMATION” MEANS DATA REQUIRED BY**
24 **THE MARYLAND DEPARTMENT OF VETERANS AFFAIRS TO VERIFY THE ELIGIBILITY**
25 **OF A VETERAN OR AN ELIGIBLE DEPENDENT FOR BURIAL IN A NATIONAL OR STATE**
26 **VETERANS CEMETERY.**

27 (ii) **“IDENTIFYING INFORMATION” INCLUDES NAME, SERVICE**
28 **NUMBER, SOCIAL SECURITY NUMBER, DATE OF BIRTH, DATE OF DEATH, PLACE OF**
29 **BIRTH, AND COPY OF THE DEATH CERTIFICATE.**

1 **(4) “VETERAN” HAS THE MEANING STATED IN § 9-901 OF THE STATE**
2 **GOVERNMENT ARTICLE.**

3 **(5) “VETERANS SERVICE ORGANIZATION” MEANS AN ASSOCIATION**
4 **OR OTHER ENTITY ORGANIZED FOR THE BENEFIT OF VETERANS THAT HAS BEEN**
5 **RECOGNIZED BY THE U.S. DEPARTMENT OF VETERANS AFFAIRS OR CHARTERED BY**
6 **CONGRESS AND ANY EMPLOYEE OR REPRESENTATIVE OF THE ASSOCIATION OR**
7 **ENTITY.**

8 **(B) IF A LICENSED FUNERAL ESTABLISHMENT OR A CREMATORY IS IN**
9 **POSSESSION OF CREMATED HUMAN REMAINS THAT HAVE BEEN UNCLAIMED FOR 90**
10 **DAYS OR MORE, THE LICENSED FUNERAL ESTABLISHMENT OR HOLDER OF THE**
11 **PERMIT FOR THE BUSINESS OF OPERATING A CREMATORY SHALL PROVIDE**
12 **IDENTIFYING INFORMATION OF THE UNCLAIMED CREMAINS TO THE MARYLAND**
13 **DEPARTMENT OF VETERANS AFFAIRS OR A VETERANS SERVICE ORGANIZATION IN**
14 **ORDER FOR THE MARYLAND DEPARTMENT OF VETERANS AFFAIRS OR VETERANS**
15 **SERVICE ORGANIZATION TO DETERMINE IF THE UNCLAIMED CREMAINS ARE THOSE**
16 **OF A VETERAN OR AN ELIGIBLE DEPENDENT.**

17 **(C) WITHIN 45 DAYS AFTER RECEIPT OF THE INFORMATION REQUIRED BY**
18 **SUBSECTION (B) OF THIS SECTION, THE MARYLAND DEPARTMENT OF VETERANS**
19 **AFFAIRS OR VETERANS SERVICE ORGANIZATION SHALL NOTIFY THE LICENSED**
20 **FUNERAL ESTABLISHMENT OR PERMIT HOLDER:**

21 **(1) WHETHER THE CREMAINS ARE THOSE OF A VETERAN OR AN**
22 **ELIGIBLE DEPENDENT; AND**

23 **(2) IF SO, WHETHER THE VETERAN OR ELIGIBLE DEPENDENT IS**
24 **ELIGIBLE FOR BURIAL IN A VETERANS CEMETERY.**

25 **(D) IF THE UNCLAIMED CREMAINS ARE THOSE OF A VETERAN OR AN**
26 **ELIGIBLE DEPENDENT, THE LICENSED FUNERAL ESTABLISHMENT OR PERMIT**
27 **HOLDER MAY TRANSFER THE CREMAINS TO THE MARYLAND DEPARTMENT OF**
28 **VETERANS AFFAIRS OR A VETERANS SERVICE ORGANIZATION FOR THE PURPOSE OF**
29 **DISPOSITION OF THE CREMAINS.**

32 **(A) A LICENSED FUNERAL ESTABLISHMENT OR HOLDER OF A PERMIT TO**
33 **ENGAGE IN THE BUSINESS OF A CREMATORY WHO ACTS IN GOOD FAITH IS NOT**
34 **CIVILLY LIABLE FOR TRANSFERRING THE UNCLAIMED CREMATED REMAINS OF A**

1 VETERAN OR AN ELIGIBLE DEPENDENT OF A VETERAN TO THE MARYLAND
2 DEPARTMENT OF VETERANS AFFAIRS OR A VETERANS SERVICE ORGANIZATION FOR
3 PURPOSES OF DISPOSITION AS PROVIDED IN § 5-803 OF THE BUSINESS
4 REGULATION ARTICLE AND § 7-406 OF THE HEALTH OCCUPATIONS ARTICLE.

5 (B) A VETERANS SERVICE ORGANIZATION THAT ACTS IN GOOD FAITH IS NOT
6 CIVILLY LIABLE FOR RECEIVING THE UNCLAIMED CREMATED REMAINS OF A
7 VETERAN OR AN ELIGIBLE DEPENDENT OF A VETERAN FOR PURPOSES OF
8 DISPOSITION AS PROVIDED IN § 5-803 OF THE BUSINESS REGULATION ARTICLE
9 AND § 7-406 OF THE HEALTH OCCUPATIONS ARTICLE.

12 (a) In this title the following words have the meanings indicated.

13 (d) “Board” means the Maryland State Board of Morticians and Funeral
14 Directors.

15 (e) (1) “Business of operating a crematory” means controlling or managing a
16 crematory.

17 (2) “Business of operating a crematory” does not include:

18 (i) The practice of funeral direction or the practice of mortuary
19 science; or

20 (ii) 1. Assistance in making decisions and filling out forms that
21 are not directly related to cremation;

22 2. Obtaining vital statistics, signatures, and other
23 information necessary to complete a death certificate;

24 3. Transportation of a body to the place of disposition; or

25 4. Any other services regarding the disposition of a body that
26 are not directly related to cremation.

27 (h) “Cremation” means the process of reducing human remains to bone fragments
28 through intense heat and evaporation, including any mechanical or thermal process.

29 (i) “Crematory” means a building, portion of a building, or structure that houses
30 the necessary appliances and facilities for cremation.

1 (k) "Funeral establishment" means any building, structure, or premises from
2 which the business of practicing mortuary science is conducted.

3 (l) (1) "Human remains" means:

4 (i) The body of a deceased person; or

5 (ii) A part of a body or limb that has been removed from a living
6 person.

7 (2) "Human remains" includes the body or part of a body or limb in any
8 state of decomposition.

9 (p) "Licensed funeral establishment" means, unless the context requires
10 otherwise, a funeral establishment that is licensed by the Board.

11 7-406.

12 (A) A licensee shall maintain a complete file of a cremation that includes the
13 signature of the next of kin, person identifying the body, or person responsible for
14 disposition, time of death, and the date and time of cremation.

15 (B) (1) (I) IN THIS SUBSECTION THE FOLLOWING WORDS HAVE THE
16 MEANINGS INDICATED.

17 (II) "ELIGIBLE DEPENDENT" MEANS A VETERAN'S SPOUSE, A
18 VETERAN'S UNMARRIED CHILD UNDER THE AGE OF 21 YEARS, OR A VETERAN'S
19 UNMARRIED ADULT CHILD WHO BEFORE THE AGE OF 21 BECAME PERMANENTLY
20 INCAPABLE OF SELF-SUPPORT BECAUSE OF PHYSICAL OR MENTAL DISABILITY.

21 (III) 1. "IDENTIFYING INFORMATION" MEANS DATA
22 REQUIRED BY THE MARYLAND DEPARTMENT OF VETERANS AFFAIRS TO VERIFY
23 THE ELIGIBILITY OF A VETERAN OR AN ELIGIBLE DEPENDENT FOR BURIAL IN A
24 NATIONAL OR STATE VETERANS CEMETERY.

25 2. "IDENTIFYING INFORMATION" INCLUDES NAME,
26 SERVICE NUMBER, SOCIAL SECURITY NUMBER, DATE OF BIRTH, DATE OF DEATH,
27 PLACE OF BIRTH, AND COPY OF THE DEATH CERTIFICATE.

28 (IV) "VETERAN" HAS THE MEANING STATED IN § 9-901 OF THE
29 STATE GOVERNMENT ARTICLE.

30 (V) "VETERANS SERVICE ORGANIZATION" MEANS AN
31 ASSOCIATION OR OTHER ENTITY ORGANIZED FOR THE BENEFIT OF VETERANS THAT
32 HAS BEEN RECOGNIZED BY THE U.S. DEPARTMENT OF VETERANS AFFAIRS OR

1 CHARTERED BY CONGRESS AND ANY EMPLOYEE OR REPRESENTATIVE OF THE
2 ASSOCIATION OR ENTITY.

3 (2) IF A LICENSED FUNERAL ESTABLISHMENT OR A CREMATORY IS IN
4 POSSESSION OF CREMATED HUMAN REMAINS THAT HAVE BEEN UNCLAIMED FOR 90
5 DAYS OR MORE, THE LICENSED FUNERAL ESTABLISHMENT OR HOLDER OF THE
6 PERMIT FOR THE BUSINESS OF OPERATING A CREMATORY SHALL PROVIDE
7 IDENTIFYING INFORMATION OF THE UNCLAIMED CREMAINS TO THE MARYLAND
8 DEPARTMENT OF VETERANS AFFAIRS OR A VETERANS SERVICE ORGANIZATION IN
9 ORDER FOR THE MARYLAND DEPARTMENT OF VETERANS AFFAIRS OR VETERANS
10 SERVICE ORGANIZATION TO DETERMINE IF THE UNCLAIMED CREMAINS ARE THOSE
11 OF A VETERAN OR AN ELIGIBLE DEPENDENT.

12 (3) WITHIN 45 DAYS AFTER RECEIPT OF THE INFORMATION
13 REQUIRED UNDER PARAGRAPH (2) OF THIS SUBSECTION, THE MARYLAND
14 DEPARTMENT OF VETERANS AFFAIRS OR VETERANS SERVICE ORGANIZATION
15 SHALL NOTIFY THE LICENSED FUNERAL ESTABLISHMENT OR PERMIT HOLDER:

16 (I) WHETHER THE CREMAINS ARE THOSE OF A VETERAN OR AN
17 ELIGIBLE DEPENDENT; AND

18 (II) IF SO, WHETHER THE VETERAN OR ELIGIBLE DEPENDENT IS
19 ELIGIBLE FOR BURIAL IN A VETERANS CEMETERY.

20 (4) IF THE UNCLAIMED CREMAINS ARE THOSE OF A VETERAN OR AN
21 ELIGIBLE DEPENDENT, THE LICENSED FUNERAL ESTABLISHMENT OR PERMIT
22 HOLDER MAY TRANSFER THE CREMAINS TO THE MARYLAND DEPARTMENT OF
23 VETERANS AFFAIRS OR A VETERANS SERVICE ORGANIZATION FOR THE PURPOSE OF
24 DISPOSITION OF THE CREMAINS.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2015.
