1 AN ACT concerning

2 **Maryland Energy Administration – Annual Report – Grants**

3 FOR the purpose of requiring that a certain annual report made by the Maryland Energy  
4 Administration to the Governor and General Assembly include certain information  
5 on the grants awarded by the Administration; and generally relating to the annual  
6 report of the Maryland Energy Administration.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

13 That the Laws of Maryland read as follows:

14 **Article – State Government**

15 9–20B–12.

16 (a) On or before January 1 of each year, the Administration shall report to the  
17 Governor and, in accordance with § 2–1246 of this article, to the General Assembly on the  
18 uses and expenditures of the Fund from the prior fiscal year.

19 (b) The report shall include:

- 1           (1) a detailed accounting of all amounts received by and disbursed from the  
2 Fund, **INCLUDING THE AMOUNT AND RECIPIENT OF EACH GRANT AWARDED BY THE**  
3 **ADMINISTRATION;**
- 4           (2) all amounts used by the Administration for administrative purposes;
- 5           (3) programs, projects, and activities included in each category under §  
6 9–20B–05(g) of this subtitle;
- 7           (4) the status of programs, projects, activities, and investments  
8 implemented with funds from the Fund, including an evaluation of the impact of the  
9 programs, projects, activities, and investments that are directed to low–income or  
10 moderate–income residential sectors or to other particular classes of ratepayers;
- 11           (5) an estimate of electricity savings from the programs, projects, activities,  
12 and investments;
- 13           (6) the number of allowances sold in each auction;
- 14           (7) the average allowance price from each auction;
- 15           (8) an estimate of revenue from future auctions; and
- 16           (9) recommendations for changes to the allocation of funds under §  
17 9–20B–05(g) of this subtitle.

18           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
19 October 1, 2015.
