- 1 (G) THIS SECTION SHALL BE KNOWN AND MAY BE CITED AS THE ANNE 2 ARUNDEL COUNTY PUBLIC SCHOOLS FUNDING ACCOUNTABILITY AND 3 TRANSPARENCY ACT.
- 4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 5 1, 2015.
