# A BILL ENTITLED

# 1 AN ACT concerning

# 2 Workgroup to Study Safe Harbor Policy for Youth Victims of Human Trafficking

3 FOR the purpose of establishing the Workgroup to Study Safe Harbor Policy for Youth 4 Victims of Human Trafficking; specifying the purpose of the Workgroup; providing  $\mathbf{5}$ for the composition, chair, and staffing of the Workgroup; prohibiting a member of 6 the Workgroup from receiving certain compensation, but authorizing the 7 reimbursement of certain expenses; establishing the duties of the Workgroup; 8 requiring the Workgroup to report its findings and recommendations to the Governor 9 and the General Assembly on or before a certain date; providing for the termination 10 of this Act; and generally relating to the Workgroup to Study Safe Harbor Policy for 11 Youth Victims of Human Trafficking.

#### 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 13 That:

14 (a) There is a Workgroup to Study Safe Harbor Policy for Youth Victims of Human15 Trafficking.

- 16 (b) The purpose of the Workgroup is to study:
- 17 (1) legal protections for youth victims of human trafficking; and
- 18 (2) the provision of services for youth victims of human trafficking.
- 19 (c) The Workgroup consists of the following members:

20 (1) one member of the Senate of Maryland, appointed by the President of 21 the Senate;

#### **SENATE BILL 521**

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 2 1, 2015. It shall remain effective for a period of 1 year and 1 month and, at the end of June 3 30, 2016, with no further action required by the General Assembly, this Act shall be 4 abrogated and of no further force and effect.
