2 **Prince George's County – Maryland–Washington Regional District – Fairness in**

4 FOR the purpose of ~~providing that, in Prince George's County, the planning board's~~
5 ~~authority is not exclusive and may be subject to review by the district council under~~
6 ~~certain circumstances; providing that the district council is not authorized to review~~
7 ~~certain matters beyond its jurisdiction as provided in a certain article; authorizing~~
8 ~~the district council in Prince George's County by local law to adopt and amend zoning~~
9 ~~law procedures for zoning decisions by the planning board and the district council;~~
10 ~~providing that within the regional district in Prince George's County, certain zoning~~
11 ~~powers granted to a planning commission or board of appeals under certain~~
12 ~~provisions shall be construed as vested exclusively in and may be exercised only by~~
13 ~~the district council;~~ requiring that, in Prince George's County, the zoning hearing
14 examiner shall issue a certain decision not less than a certain time after the date of
15 a certain hearing; altering the circumstances under which a certain person or entity
16 aggrieved by a certain decision of the district council may request judicial review of
17 any final decision of the district council; repealing the authority of a certain person
18 to request judicial review of a decision of the county planning board; providing that,
19 in Prince George's County, a person may file make a request for judicial to the district
20 council for the review of a decision of a ~~board of appeals to the circuit court~~ zoning
21 hearing examiner or the planning board only under certain circumstances; providing
22 that, in Prince George's County, when the district council is hearing a zoning matter
23 that has been appealed from a zoning hearing examiner, the district council may
24 remand the zoning matter back to the zoning hearing examiner only one time and is
25 required to specify that the zoning hearing examiner take action within a certain

- 22 (a) A district council may amend its zoning laws, including any maps:
 - 23 (1) in accordance with procedures established in its zoning laws; and
 - 24 (2) after holding an advertised public hearing.
- 25 (b) The procedures and zoning laws may include:
 - 26 (1) procedures limiting the times when amendments may be adopted;

1 (2) provisions for hearings and preliminary determinations by an
2 examiner, a board, or any other unit;

3 (3) procedures for quorums, number of votes required to enact
4 amendments, and variations or increases based on factors such as master plans,
5 recommendations of the hearing examiner, county planning board, municipal corporation,
6 governed special taxing district, or other body, and petitions of abutting property owners,
7 and the evidentiary value that may be accorded to any of these factors; and

8 (4) procedures for hearings, notice, costs, fees, amendment of applications,
9 recordings, reverter, lapse, and reconsideration de novo of undeveloped zoning
10 amendments.

11 (c) (1) In Prince George's County, the district council may provide for notice of
12 the public hearing on a proposed amendment to its zoning plan or zoning laws to be given
13 to the owners of properties, as they appear on the assessment rolls of the county, adjoining,
14 across the road from, on the same block as, or in the general vicinity of the property that
15 is the subject of the proposed amendment.

16 (2) A zoning law adopted under this subsection may require notice to be
17 given by mail or by posting the notice on or in the vicinity of the property involved in the
18 proposed amendment or both.

19 (d) **IN PRINCE GEORGE'S COUNTY, THE ZONING HEARING EXAMINER**
20 **SHALL ISSUE A DECISION ON A ZONING MATTER NOT MORE THAN 100 DAYS AFTER**
21 **THE DATE OF THE LAST HEARING HELD BY THE HEARING EXAMINER.**

23 amend a zoning law from November 1 and until the newly elected district council has taken

27 an individual map amendment or a sectional map amendment, may be requested by ANY
28 PERSON OR ENTITY THAT IS AGGRIEVED BY THE DECISION OF THE DISTRICT

30 (i) [any] A municipal corporation, governed special taxing district,
31 or person in the county;

32 (ii) [any] A civic or homeowners association representing property
33 owners affected by the final decision; [or]

3 (a) (1) Within 30 days after the county planning board takes final action on an
4 application for subdivision approval, judicial review may be requested by:

5 (i) a person aggrieved by the action; or

6 (ii) a [person or] municipal corporation that appeared at the hearing
7 in person, by attorney, or in writing.

8 (2) A petition for judicial review filed under this section may be made to
9 the circuit court for the appropriate county.

10 (3) The court may:

11 (i) affirm or reverse the action; or

12 (ii) remand the action to the county planning board for further
13 consideration.

14 (b) (1) If a petition for judicial review is filed under this section, a copy of the
15 petition shall be served on the county planning board in accordance with Maryland Rule
16 7-202(d).

17 (2) On receiving a copy of the petition, the county planning board shall:

18 (i) promptly give notice of the petition to all parties to the
19 proceeding before it; and

20 (ii) within 30 days after the filing of the petition, file with the circuit
21 court:

22 1. the originals or certified copies of all papers and evidence
23 presented to the county planning board in the proceeding before it; and

24 2. a copy of its opinion and resolution deciding the
25 application.

26 (3) Any party to the proceeding in the circuit court aggrieved by the
27 judgment of the court may appeal from the judgment to the Court of Special Appeals.

28 (4) The review proceedings provided by this section are exclusive.

15 IN PRINCE GEORGE’S COUNTY, WHEN THE DISTRICT COUNCIL IS HEARING A
16 ZONING MATTER THAT HAS BEEN APPEALED FROM A DECISION OF A ZONING
17 HEARING EXAMINER, THE DISTRICT COUNCIL:

18 (1) MAY REMAND THE ZONING MATTER BACK TO THE ZONING
19 HEARING EXAMINER ONLY ONE TIME; AND

20 (2) SHALL SPECIFY THAT THE ZONING HEARING EXAMINER TAKE
21 ACTION WITHIN ~~100~~ 30 DAYS AFTER THE MATTER IS REMANDED AND RELEVANT
22 INFORMATION IS RECEIVED FROM THE APPLICANT OR THE DISTRICT COUNCIL.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
