BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: 13 14 Article 17 - Prince George's County 15 10-187.16 Subject to the provisions of subparagraphs (B), (C), and (D) of 17 this paragraph, for a sale of improved residential real property to a Prince George's County police officer or deputy sheriff or a municipal police officer who operates in Prince George's 18 19 County who will occupy the property as a principal residence: 20 The transfer tax authorized under Subsection (a) of this 21 Section does not apply to the police officer's or deputy sheriff's first purchase of residential 22 real property in Maryland that is located in Prince George's County; and

1 (ii) The rate of the transfer tax authorized under Subsection 2 (a) of this Section may not exceed 1.0% for the police officer's OR DEPUTY SHERIFF'S 3 second or subsequent purchase in Prince George's County. 4 (B) If there are two (2) or more grantees, an exemption or rate 5 reduction under this paragraph applies if at least one (1) grantee is a Prince George's County police officer or deputy sheriff or a municipal police officer who operates in Prince 6 7 George's County. 8 (C) To qualify for an exemption or a rate reduction under this 9 paragraph, at least one (1) grantee, other than a co-maker or guarantor, must: 10 (i) Occupy the residence as the grantee's principal residence; 11 and 12 Be employed as a police officer or deputy sheriff by Prince (ii) 13 George's County or a municipal corporation in Prince George's County for a minimum of 14 three (3) years following the purchase of the residential property. 15 (D) If a police officer or deputy sheriff who receives an exemption or rate reduction under this paragraph fails to satisfy the requirements of subparagraph (C) 16 17 of this paragraph, the police officer or deputy sheriff shall pay the balance of the transfer 18 tax that would have been payable without the exemption or rate reduction. 19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 20 1, 2015.
