6 Council; and generally relating to the Maryland Electric Vehicle Infrastructure

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
25 That the Laws of Maryland read as follows:

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That:

5 (b) There is a Maryland Electric Vehicle Infrastructure Council.

6 (h) (1) On or before [December 1, 2013 and December 1, 2014] **DECEMBER 1,**
7 **2015, DECEMBER 1, 2016, DECEMBER 1, 2017, AND DECEMBER 1, 2018,** the Council
8 shall submit interim reports of its work and recommendations to the Governor and, subject
9 to § 2–1246 of the State Government Article, the General Assembly.

10 (2) On or before [June 30, 2015] **JUNE 30, 2020,** the Council shall submit
11 a final report of its work and recommendations to the Governor and, subject to § 2–1246 of
12 the State Government Article, the General Assembly.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
14 1, 2011. It shall remain effective for a period of [4] **9** years and, at the end of June 30,
15 [2015] **2020,** with no further action required by the General Assembly, this Act shall be
16 abrogated and of no further force and effect.

23 **2015, DECEMBER 1, 2016, DECEMBER 1, 2017, AND DECEMBER 1, 2018,** the Council
24 shall submit interim reports of its work and recommendations to the Governor and, subject
25 to § 2–1246 of the State Government Article, the General Assembly.

26 (2) On or before [June 30, 2015] **JUNE 30, 2020,** the Council shall submit
27 a final report of its work and recommendations to the Governor and, subject to § 2–1246 of
28 the State Government Article, the General Assembly.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
30 1, 2011. It shall remain effective for a period of [4] **9** years and, at the end of June 30,
31 [2015] **2020,** with no further action required by the General Assembly, this Act shall be
32 abrogated and of no further force and effect.

33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
34 1, 2015.
