CHAPTER _____

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2011 – Montgomery County –**
3 **Water Park at Bohrer Park**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2011 to
5 provide that certain grants for the Water Park at Bohrer Park may not terminate
6 before June 1, 2016; making this Act an emergency measure; and generally relating
7 to amending the Maryland Consolidated Capital Bond Loan of 2011.

8 BY repealing and reenacting, with amendments,
9 Chapter 396 of the Acts of the General Assembly of 2011
10 Section 1(3) Item ZA02(BG) and Item ZA03(AT)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Chapter 396 of the Acts of 2011**

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That:

16 (3) ZA02 LOCAL SENATE INITIATIVES

17 (BG) Water Park at Bohrer Park. Provide a grant equal to the lesser
18 of (i) \$80,000 or (ii) the amount of the matching fund provided,

 13 **NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THIS**
 14 **GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2016**
 15 (Montgomery County) 125,000

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
 17 measure, is necessary for the immediate preservation of the public health or safety, has
 18 been passed by a yea and nay vote supported by three-fifths of all the members elected to
 19 each of the two Houses of the General Assembly, and shall take effect from the date it is
 20 enacted.
