13 WHEREAS, In December 2014, the United States Congress passed and the  
14 President signed into law the Achieving a Better Life Experience (ABLE) Act; and

15 WHEREAS, The ABLE Act amended the Internal Revenue Code by creating a tax  
16 exemption for savings accounts to assist individuals with disabilities and their families in  
17 building savings to pay for qualified disability expenses; and

18 WHEREAS, ABLE accounts are intended to supplement, not supplant, essential  
19 benefits provided through private insurance, Medicaid, Supplemental Security Income,  
20 employment earnings, and other sources of financial support; and

21 WHEREAS, ABLE accounts can help fund qualified expenses for individuals with  
22 disabilities, including medical and dental care, education, housing, transportation,  
23 obtaining and maintaining employment, assistive technology, and community-based  
24 services and supports; and

25 WHEREAS, The ABLE Act is designed to assist individuals with disabilities and  
26 their families to save private funds, through the creation of ABLE accounts, for the purpose  
27 of maintaining the health, independence, and quality of life of individuals with disabilities;  
28 and

29 WHEREAS, The ABLE Act provides the State the opportunity to establish and  
30 operate an ABLE savings program to benefit qualified Marylanders with disabilities; now,  
31 therefore,

32 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
33 That:

1           (a) “Maryland ABLE Program” means a program in Maryland allowing disabled  
2 individuals or their families to establish savings accounts to pay qualified expenses for  
3 disabled individuals authorized under the federal Achieving a Better Life Experience  
4 (ABLE) Act.

5           (b) It is the intent of the General Assembly that the State establish a Maryland  
6 ABLE Program.

7           (c) If the Task Force established under Section 2 of this Act determines that  
8 legislation is needed to establish the Maryland ABLE Program, the General Assembly shall  
9 consider legislation that is introduced in response to the findings of the Task Force.

10           SECTION 2. AND BE IT FURTHER ENACTED, That:

11           (a) There is a Task Force on the Maryland Achieving a Better Life Experience  
12 (ABLE) Program.

13           (b) The Task Force consists of the following members:

14           (1) two members of the Senate of Maryland, appointed by the President of  
15 the Senate;

16           (2) two members of the House of Delegates, appointed by the Speaker of  
17 the House;

18           (3) the State Treasurer, or the Treasurer’s designee;

19           (4) the Attorney General, or the Attorney General’s designee;

20           (5) the Secretary of Disabilities, or the Secretary’s designee;

21           (6) the Secretary of Health and Mental Hygiene, or the Secretary’s  
22 designee;

23           (7) the Executive Director of the College Savings Plans of Maryland Board,  
24 or the Executive Director’s designee; and

25           (8) the following six members, appointed by the Governor:

26           (i) two members who have significant experience in actuarial  
27 analysis, finance, accounting, investment management, or other areas that are relevant to  
28 the Task Force;

29           (ii) one member who is an individual with a disability;

30           (iii) one member who is a family member of an individual with a  
31 disability; and

1                   (iv) two representatives of community-based organizations that  
2 support or advocate for individuals with disabilities.

3           (c)   The Governor shall designate the chair of the Task Force.

4           (d)   The Department of Disabilities shall provide staff for the Task Force, with  
5 support from the College Savings Plans of Maryland, the Treasurer's Office, and the  
6 Comptroller's Office.

7           (e)   A member of the Task Force:

8                   (1)   may not receive compensation as a member of the Task Force; but

9                   (2)   is entitled to reimbursement for expenses under the Standard State  
10 Travel Regulations, as provided in the State budget.

11           (f)   The Task Force shall:

12                   (1)   develop a plan for implementing the Maryland ABLE program;

13                   (2)   study issues related to the Maryland ABLE program, including:

14                           (i)   what the structure of the program should be;

15                           (ii)   whether the program should be State-sponsored or  
16 privately-run; and

17                           (iii)   if State-sponsored, whether the program should be operated by  
18 the College Savings Plans of Maryland or another State agency;

19                   (3)   determine the staffing and funding needs of the program;

20                   (4)   identify potential sources of start-up funding prior to the program  
21 becoming self-supporting;

22                   (5)   determine the membership of the Board that will oversee the program,  
23 the duties of the Board, and the Board's governance structure;

24                   (6)   determine the State tax benefits or treatment of contributions to and  
25 withdrawals from ABLE accounts;

26                   (7)   hold public hearings for public input to inform the deliberations of the  
27 Task Force; and

28                   (8)   recommend legislation to be introduced in the 2016 Session of the  
29 General Assembly that implements the recommendations of the Task Force.

1           (g) On or before December 1, 2015, the Task Force shall report its findings,  
2 recommendations, and proposed legislation necessary to establish the ABLE Program to  
3 the Governor and, in accordance with § 2-1246 of the State Government Article, the  
4 General Assembly.

5           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
6 1, 2015. It shall remain effective for a period of 1 year and 1 month and, at the end of June  
7 30, 2016, with no further action required by the General Assembly, this Act shall be  
8 abrogated and of no further force and effect.
