St. Mary's County - Animal Regulations

FOR the purpose of repealing provisions authorizing the County Commissioners of St. Mary's County to pass rules, regulations, or resolutions relating to dog licenses, the prohibition of dogs running at large off the property of the owner, the seizure and disposal of dogs found running at large, and the confinement of female dogs in heat; repealing provisions authorizing the county commissioners to delegate, by written contract, the enforcement of certain rules, regulations, or resolutions; authorizing the county commissioners to enact a local law to provide a comprehensive system for the regulation, humane treatment, and keeping of domestic animals and wild animals kept in captivity; authorizing a certain local law to include a schedule of fines for designated violations; providing that a violation of a certain local law is a civil infraction; and generally relating to the regulation of certain animals in St.

Mary's County.



The County Commissioners of St. Mary's County may provide an 1 (1)(e) 2 animal shelter for the placement of dogs seized by animal control officers. 3 (2)The county commissioners may enter into agreements with adjacent 4 counties to establish an animal shelter to serve the counties. 5 The county commissioners may contract with an animal welfare society, (3)6 a humane society, or any other qualified person to: 7 (i) establish an animal shelter; or 8 seize, dispose of, or euthanize stray, injured, or sick dogs. (ii) 9 **(4)** The County Commissioners of St. Mary's County may pay any expenses arising from the operation of this subsection. 10 Notwithstanding § 13-105(d) of this subtitle, the county 11 (ii) 12 commissioners may use proceeds from dog license fees to: 13 1. establish an animal shelter; or 2. 14 collect, dispose of, or euthanize stray, injured, or sick dogs. 15 (f) The County Commissioners of St. Mary's County, by rule, regulation, 16 or resolution, may provide that an owner of a dog may not allow the dog, whether licensed 17 or unlicensed, to run at large off the premises of the owner. 18 A rule, regulation, or resolution passed under this subsection may allow 19 the following dogs to run at large when accompanied by the owner or agent of the owner 20 and when kept within sight or calling distance of the owner or agent: 21(i) dogs proved to be obedient, in accordance with rule, regulation, or resolution of the county; 2223 (ii) dogs being used or trained for hunting; and 24 (iii) dogs accompanied by the owner on horseback. 25 The county commissioners, by rule, regulation, or resolution, may provide for enforcement and investigation of reports of violations of a rule, regulation, or 26 27 resolution passed under this subsection.
