BY repealing and reenacting, without amendments, Article – Natural Resources Section 5-212(g)Annotated Code of Maryland (2012 Replacement Volume and 2014 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Natural Resources 5-212.Subject to paragraph (3) of this subsection, the Fund may be used only (g) (1) for:

26 27 28	SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly in enacting this Act to ratify the amendments to § 5–212(g) of the Natural Resources Article, as enacted by Chapter 464 of the Acts of the General Assembly of 2014.
29 30	SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2015 .
