Senate Bill 400 (Senator Pugh, et al.)

Education, Health, and Environmental Affairs Health and Government Operations

State Government - Commemorative Months - Alzheimer's and Brain Awareness Month

This bill requires the Governor to annually proclaim June as Alzheimer's and Brain Awareness Month in recognition of all Marylanders including family caregivers, who have been touched by Alzheimer's disease and other brain-related diseases. The proclamation must urge the Department of Health and Mental Hygiene (DHMH) and the Maryland Department of Aging (MDoA), in conjunction with related public health and advocacy entities, to observe Alzheimer's and Brain Awareness Month properly with appropriate programs, ceremonies, and activities, including (1) caregiver summits in honor of The Longest Day team event to provide public input regarding caregiving needs, challenges, and barriers and (2) as appropriate, updates from the Virginia I. Jones Alzheimer's Disease and Related Disorders Council.

Fiscal Summary

State Effect: Urging DHMH and MDoA to observe Alzheimer's and Brain Awareness Month does not affect State finances as they are granted flexibly in how to commemorate the occasion.

Local Effect: None.

Small Business Effect: None.

Analysis

Current Law: Twelve official commemorative days and six months are recognized in State law as shown in **Exhibit 1**. The Governor also must issue a proclamation each year encouraging citizens and other individuals to observe a moment of silence at 3 p.m. on

Memorial Day to unite in remembrance and commemorate the heroic acts and efforts of Marylanders who have served and died in the U.S. Armed Forces.

Background: As noted in the preamble and according to the Alzheimer's Association, Alzheimer's disease, a progressive neurodegenerative brain disorder tragically robs individuals of their memories and leads to progressive mental and physical impairments. Alzheimer's disease is the sixth-leading cause of death in the United States, the ninth-leading cause of death in Maryland and is the only cause of death in the top 10 that has no cure, no treatment, and no way to slow its progression. More than 5 million people in the United States are living with Alzheimer's disease, including 97,000 Marylanders.

The cost of caring for people with Alzheimer's disease in the United States exceeds \$200 billion per year, and those costs are expected to rise dramatically with the increase in the numbers of older people in the coming decades. There are over 286,000 dedicated caregivers in Maryland who provide unpaid care at home valued at more than \$4 billion. Medicare and most private health insurance do not cover the long-term services and support that most people with Alzheimer's disease and dementia need. According to the National Institute on Aging, Alzheimer's disease indirectly costs businesses up to \$37 billion a year in lost productivity for employees who miss work or leave their jobs to provide care for a relative.

Researchers in Maryland and around the world continue their efforts to develop scientific breakthroughs that could one day bring about a world without Alzheimer's disease. There is a need to raise awareness about Alzheimer's disease and to honor all the caregivers who support and care for loved ones with Alzheimer's disease.

Chapter 305 of 2013 established the Virginia I. Jones Alzheimer's Disease and Related Disorders Council to continue the work of the Maryland Alzheimer's Disease and Related Disorders Council. The council's charge includes developing and monitoring the 2012 Maryland State Plan on Alzheimer's Disease and Related Disorders devised by the commission. The council is staffed by the MDoA and DHMH.

Several nonprofit organizations worldwide commemorate Alzheimer's and Brain Awareness Month in June. President Obama declared November 2009 as National Alzheimer's Disease Awareness Month.
