BY repealing and reenacting, with amendments, Article – Public Safety Section 2-412 Annotated Code of Maryland (2011 Replacement Volume and 2015 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Public Safety 2-412.(a) In this section the following words have the meanings indicated. (1) "Emergency" means a sudden or unexpected happening or an unforeseen combination of circumstances that calls for immediate action to protect health, safety, welfare, or property from actual or threatened harm or from an unlawful act.
